- Drywall/Gypsum tipping rates increased—testing for asbestos required
- Wrecked Automobiles/ trucks are prohibited
- Minimum charge for motorhomes
- Commercial cardboard is no longer accepted

We invite you to a public meeting to discuss how the tipping fee increases and other changes at the **Alberni Valley Landfill** may affect your business.

On May 24, 2017, the ACRD Board of Director's adopted the amendment to Bylaw R1027-1 cited as *Alberni Valley Landfill Tipping Fee and Regulation Amendment Bylaw, 2017.* The purpose of this Bylaw update is to enable the AVLF to align tipping fees with the current rates charged on Vancouver Island enabling the necessary projects required for improved and efficient waste diversion in our region.

The acceptance procedures for **gypsum (drywall)** have changed due to safety and environmental requirements. Pre 1990 materials can contain asbestos and will not be accepted for recycling unless tested. Please turn over for more information.

AMENDMENT BYLAW No. R1027-1

WILL COME INTO EFFECT

JULY 1, 2017

<u>Tarp your load</u>

As of July 1, 2017, at the AV Landfill, any untarpped load will be charged a rate of \$240/tonne to dump. All loads must be inside an enclosed vehicle or tarpped, with no exceptions.





For patrons who are wishing to dispose of drywall/gypsum at the **Alberni Valley Landfill** will need to follow new acceptance procedures designed to reduce the risk of asbestos exposure.

Builders and manufacturers have used asbestos for many years in building products. When installed correctly and properly maintained, there is little risk for exposure to the public. However, when disturbed or not maintained, asbestos fibers can be released into the air, which can lead to serious health consequences.

Mud enhanced with asbestos was also frequently used in the installation of drywall. By 1990, this practice had stopped, but a significant portion of buildings on Vancouver Island may have asbestos adhering to their drywall. Fortunately, only a small percentage of asbestos was added to the mud but it still needs to be handled properly.

DOES YOUR DRYWALL CONTAIN ASBESTOS?

If your building was built prior to 1990, it does not necessarily mean that asbestos was used. Below are ways a property owner can determine if their drywall is asbestos free:

- Document proof that the building under consideration was constructed after 1990. Your municipal or Regional District office's property records can validate this.
- The date written on the drywall indicating when it was made. Usually the manufacture date is printed in the back of the drywall.
- Letter or report from a qualified person vouching that a hazardous material inventory has been conducted and actions have been preformed to secure any risks.

If a building owner or contractor is able to pass one of these requirements, the tipping fee will be \$250 per tonne. If unable to pass one of these tests, we will have to assume there is asbestos present in the drywall and a tipping fee of \$250 per tonne will be charged plus the cost of packaging. If the construction waste is not separated from the asbestos drywall, then the rate of \$500 per tonne will be applied.

HOW TO PROPERLY DISPOSE OF DRYWALL CONTAINING ASBESTOS AT THE LANDFILL

When delivering your drywall containing asbestos at the AV Landfill, certain procedures will need to be followed. Contractors are required to have all material containing asbestos packaged properly. Impending procedures are currently being reviewed and will be made available in the coming weeks on our website and at the public information session.
