# **Clean Wood Waste**

## **Information Sheet**

Selected wood waste products at the Alberni Valley Landfill will now be diverted from the landfill. The table below provides details on wood waste that will be accepted for diversion and wood waste that will be classified as garbage.

Wood Waste Accepted for Recycling	Wood Waste Classified As Garbage
Raw, untreated pallets	Painted & stained items
Wood scraps (no pressure treated)	Pressure treated items (green or brown coating)
Particle board without laminate	Laminate Flooring
<ul> <li>Plywood without paint</li> </ul>	Laminate
Hardwood flooring (no laminate)	Cedar shakes
May include nails	Creosote items
	Cement Board / Hardi-plank

As of July 1, 2017 the tipping fee for wood waste will be \$120 per tonne.

Should loads of wood waste be mixed together, when they arrive at the landfill, or mixed with regular municipal solid waste (MSW), or construction and demolition waste, haulers will be charged the "MSW mixed with recyclables" rate. At \$240 per tonne.

### What happens to wood waste that is diverted from the landfill?

Wood waste that is accepted for diversion is grinded and recycled into hog fuel for biomass energy recovery, compost and landscaping.

## **The Environmental Story**

Contrary to popular belief, wood that ends up in a landfill does not simply biodegrade and create soil. Instead, it actually generates harmful, polluting gases if allowed to rot.

## **Information Sheet - Asbestos disposal bags**

This hand out is to provide Alberni Landfill customers with important safety information prior to the purchase or use of an asbestos disposal bag.

#### What is an asbestos disposal bag?

Asbestos should always be removed from your home by a qualified professional. If you choose to dispose of asbestos containing products on your own, there is a legal requirement to **double bag** asbestos material in 6 Mil poly asbestos disposal bags. The bags must be goose-neck tied and sealed with duct tape (see below).

The required 6 Mil poly asbestos disposal bags are available for purchase at the Alberni-Clayoquot Regional District office and the Alberni Landfill site at a cost of \$2.00 per bag, including tax.

#### How to properly fill your asbestos disposal bags

- 1. Wear protective equipment when handling asbestos and minimize dust generated, as specified in Work Safe BC's "Safe Work Practices for Handling Asbestos".
- 2. Carefully place asbestos containing items in designated asbestos disposal bag.
- 3. DO NOT overfill the bag leave enough space to properly tie it.
- 4. Wipe the outside of the bag clean with a wet paper towel and then dispose of the solid paper towel in with your asbestos material.
- 5. Tie bag goose-neck style with a wet paper towel and then dispose of the soiled paper towel in with your asbestos material.



6. Place sealed bag in a second asbestos disposal bag and repeat step #4.

#### How to properly dispose of asbestos

The Alberni Valley Landfill accepts asbestos, as long as the load is properly bagged and sealed and weighs less than 1,000 kg. Mulitple load volumes must not exceed this limit in a 30 day period.

#### Please note:

Loads over 1000 kg are required by law to provide a valid Hazardous Waste Transport License.

Any customer over the allowable number of visits per year will be required to provide a Provincial Identification Number to show that a Registration of Hazardous Waste Generators application has been approved by the Province.
