Information About Application

What is the Local Government Election?

The Alberni-Clayoquot Regional District is holding by-elections on April 6, 2019 for the Office of Electoral Area Director(s) for Beaufort and Cherry Creek.

Who can request a Mail Ballot Voting Package?

Eligible voters can apply to vote by mail if any of the following conditions apply:

- 1. You expect to be absent from the regional district electoral area at the times of all Advance Voting Opportunities (March 27 and April 2) and on By-Election Voting Day (April 6), or
- 2. You have a physical disability, illness or injury that affects your ability to vote at another voting opportunity for this election.
- 3. Reside in Electoral Areas: "B" (Beaufort) or "F" (Cherry Creek) that are remote from the voting places at which they are entitled to vote where their only access to their residence is by boat or aircraft, or their travel time by road from their residence to the nearest voting place at which the person is entitled to vote is greater than thirty (30) minutes.

Eligible voters applying to vote by mail must be:

- 1. 18 years of age or older on April 6, 2019; AND
- 2. a Canadian citizen; AND
- 3. a resident of the regional district electoral area for at least the past 30 days **OR** a non-resident owner of real property in the regional district electoral area for at least the past 30 days; **AND**
- 4. a resident of BC for at least the past 6 months; AND
- 5. not disqualified by law from voting in an election.

What delivery methods are available for my Mail Ballot Voting Package?

The following options are available for delivery of your Mail Ballot Voting Package:

- 1. Keep the package at the ACRD Office for you to pick up
- 2. Mail the package to your residential address
- 3. Mail the package to an address you specify

When will I receive my Mail Ballot Voting Package?

If your application is filled out correctly, the Chief Election Officer will send you a mail ballot package starting **March 15, 2019.** If your application is received after March 29th and time does not permit mailing, you should arrange to pick up a package from the ACRD Office, 3008 Fifth Avenue, Port Alberni, BC.

How do I request my Mail Ballot Voting Package?
