Watering Restrictions—Stage 2 are in effect July 13, 2015 to October 15, 2015

Due to low reservoir levels it is necessary to impose restrictions on Outdoor Water Use including **garden and lawn** watering.

Therefore effective 12:01 a.m. July 13th, 2015 and until further notice, Outdoor Water Use is restricted as follows:

<u> Lawn Sprinkling</u> -

Even numbered addresses can sprinkle on Wednesdays and Saturdays 6-9 am OR 7-10 pm.

Odd numbered addresses can sprinkle on Thursdays and Sundays $6-9~{
m am~OR}~7-10~{
m pm}.$

Vegetable Gardens, planters, shrubs and trees -

Watering must be done by a timed watering system or by hand using a spring loaded shut off nozzle or bucket. 6 – 9 am or 7 – 10 pm. 2 hours per day maximum – any day.

Private pools, spas and garden ponds Public and commercial fountains (recirculating)

Filling is prohibited, topping up is permitted.

Outdoor washing of cars, boats and houses -

Washing must be done by hand using a spring loaded shut off nozzle or bucket. Anytime.

Washing driveways and sidewalks -

All forms of washing using treated drinking water are prohibited.

Commercial car washing, gardens -

Exempt.

Please be advised that effective July 1, 2015, the Alberni-Clayoquot Regional District will be banning recyclable corrugated cardboard from industrial, commercial and institutional sources from disposal at the Alberni Valley Landfill.

The banning of this recyclable resource under Bylaw R1027 will save valuable landfill space, energy and resources. The onus has been placed on all of us to comply with this important waste reduction initiative.

Your business may already be in the practice of cardboard recycling. If not, please contact one of the haulers listed below to determine what carbdboard collection recycling services it offers.

There are two components to the implementation of this disposal ban: thresholds and surcharges. The term threshold refers to the acceptable amount of banned material allowed in each load and surcharge refers to the penalty charged if the amount exceeds the threshold.
