
How is the financial plan developed?

 - Contractors




- The draft presents what it takes to continue to do what has been done based on board priorities recognizing regulatory requirements, state of infrastructure and the expressed interest of the directors.

Service Financial Rules

- Areas are only charged for the services they are provided
- Services are independent you cannot transfer revenues and expenditures between services
- The entire Board is responsible for each service





Financial Plans

Alberni-Clayoquot Regional District

- Annually adopt 5 year plan by March 31st
- Budget of approximately \$25.3 million per year

Alberni-Clayoquot Regional Hospital District

- Provisional and annual budget
- Budget of approximately \$1.69 million per year






2016 Expenditures by Service






2016 Sources of Revenue






2016 Region Wide Apportionment






2016 Alberni Valley Apportionment

Tax rates

- There is a tax rate for each service
- Each property may fall within multiple service areas therefore must consider what services are provided to each when comparing
- A collection charge of 5.25% is added onto requisition by the Surveyor for rural areas





Land & Improvements

- Regional District's use converted (adjusted) land & improvements, as provided by BC Assessment, for the basis of the requisition
 - The conversion tax rates are provided by the province through regulation and are currently:

Class of Property	Percentage to be applied
1 – Residential	10.0%
2 – Utilities	35.0%
3 – Supportive housing	10.0%
4 – Major Industry	34.0%
5 – Light Industry	34.0%
6 – Business	24.5%
7 – Managed Forest Land	30.0%
8 – Recreational Property	10.0%
9 – Farm Land	10.0%

Regional Hospital District

- Capital funds for the hospital facilities within the Region
- West Coast General Hospital, Tofino General Hospital, Bamfield Health Centre




Hospital District Budget

- The Regional Hospital District is paying for 40% of the West Coast General Hospital construction.
- Budget includes a \$550,000 equipment grant, as in prior years, to the Island Health
- A renovation of the West Coast General Hospital Emergency Room was planned in 2014 by Island Health originally at a total cost of \$4 million and the scope is being evaluated – should be in the 2017-18 budget
- Current year includes new X-ray equipment and new Chiller
- Debt payment accounts for approximately half of the budget – virtually all debt will be paid off in 2022





ACRHD Requisition



Residential Tax Rate \$0.289 per \$1,000 of assessed value



AV Landfill Tipping Fees....

- Alberni Valley Landfill costs recovered by tipping fees - City charged at the landfill.
- Fees to increase from \$95/ton to \$115/ton in 2016.
- Fees are the lowest on the island and pay for operating and capital costs!
