Summary:

The Regional Hospital District paid for 40% of the West Coast General Hospital construction using long term debt secured through the Municipal Finance Assocation (MFA). The balance of the debt outstanding is estimated to be approximately \$6.8 million at the end of 2014. Debentures have begun expiring in the past couple of years resulting in decreased costs to service the debt.

As in prior years, the provisional budget includes an equipment grant of \$550,000 for Island Health to purchase equipment and complete smaller scale projects for the hospitals in the Region. In 2014 Island Health also identified a major renovation of the WCGH Emergency Room as a high priority with the project to be completed in 2014/2015. The total estimated project cost is \$4,026,000 which makes the ACRHD 40% share \$1,610,400. The 2014 ACRHD budget included a budget item of \$1,000,000 for this project and therefore the remaining \$610,400 has been budgeted for 2015.

Island Health will be providing the Board a formal request, with a description of projects, by January 31st, 2015. It is anticipated that the Heli-pad project at the Tofino Hospital will be the main item in their plan.

Time Requirements – Staff & Elected Officials:

There will be some time required of staff and elected officials to review the specific funding requests as they are received from Island Health.

Financial:

The provisional budget sees a tax requisition increase of 1.85% from 2014.

Policy or Legislation:

The Alberni-Clayoquot Regional Hospital District is required by Section 23 of the Hospital District Act to adopt a provisional budget by December 31 for the following year.


