#### **Recommendation:**

#### **Summary:**

The Regional Hospital District paid for 40% of the West Coast General Hospital construction using long term debt secured through the Municipal Finance Assocation (MFA). The balance of the debt outstanding is estimated to be approximately \$5.9 million at the end of 2015.

Debentures have begun expiring in the past couple of years resulting in decreased costs to service the debt. The interest rates of renewed debenture debt has been at lower rates which has reduced the interest costs significantly in many cases. When the opportunity to retire debt arises it will be explored if the ability to do so can be done within the current taxation levels for the Hospital District. Currently the provisional budget may allow a \$500,000 debt pay down in 2016 if no additional large capital projects are identified.

As in prior years, the provisional budget includes an equipment grant of \$550,000 for Island Health to purchase equipment and complete smaller scale projects for the hospitals in the Region. It is anticipated that the Heli-pad project at the Tofino Hospital and Bamfield have been increased in priority and will be included in the annual equipment grant as the cost does not meet large will be the main item in their plan.

In 2014 Island Health also identified a major renovation of the WCGH Emergency Room as a high priority with the project to be completed in 2014/2015, this did not occur. The project was intially estimated at a project cost is \$4,026,000 which makes the ACRHD 40% share \$1,610,400. Discussions

with Chris Sullivan from Island Health indicate the scope of the project is under review and the project is is currently in the 2018/19 capital plan for Island Health. The 2014 ACRHD budget included a budget item of \$1,000,000 for this project and therefore the remaining \$610,400 which could be budgeted in the next three years.

Island Health will be providing the Board a formal request, with a description of projects, by January 31<sup>st</sup>, 2016, at this time projects such as the Heli-pads and the WCGH Emergency room may move up the priority list.

#### Time Requirements - Staff & Elected Officials:

There will be some time required of staff and elected officials to review the specific funding requests as they are received from Island Health.

#### **Financial:**

The provisional budget currently is set for no tax increase over 2015 and will await the confirmation from Island Health any projects by January 31<sup>st</sup> 2016.

#### **Policy or Legislation:**

The Alberni-Clayoquot Regional Hospital District is required by Section 23 of the Hospital District Act to adopt a provisional budget by December 31 for the following year.


# Bylaw No. 119
