Subject: 2015 Annual Budget

Recommendation:

That the Alberni Clayoquot Regional Hospital District Board of Directors give second and third reading as well as adoption to Bylaw 118, cited as "Alberni-Clayoquot Regional Hospital District 2015 Annual Budget No. 118".

Summary:

The Regional Hospital District paid for 40% of the West Coast General Hospital construction using long term debt secured through the Municipal Finance Authority (MFA). The balance of the debt outstanding was approximately \$6.8 million at the end of 2014.

In addition to funding the long term borrowing for the West Coast General Hospital the Hospital District also provides Island Health funding to complete other capital projects and purchase equipment for our region. Island Health provided a letter to the Board at the February 11th Regional Hospital District meeting explaining their 2015 capital plan. This included a plan for the \$550,000 annual equipment grant that the Hospital District.

The planned Emergency Department (ER) renovation at the WCGH has been deffered to 2018 and discussions with Chris Sullivan has determined that there is no additional projects planned in 2015/16 year for the ACRHD. The ER renovation was a major project valued at approximately \$4 million of which the Hospital District will be responsible for 40% of the costs or \$1.6 million. The 2014 Annual Budget included \$1 million in funding for this project with the remaining \$600,000 to be requisition in 2015. The project has been deffered therefore we will delay that requisition amount. In an effort to avoid a negative spike in the tax requisition in the next couple of years staff identified options for smoothing out the requisition and will making early payments on the outstanding debenture debt that is coming up for renewal in early 2016.

Time Requirements - Staff & Elected Officials:

There will be some time required of staff and elected officials to review the specific funding requests as they come in from the Vancouver Island Health Authority.

Financial:

The requisition is 14.71% lower than that of the prior year. The residential tax rate has decreased from \$0.353 to \$0.294 per \$1,000 of assessed value.

Policy or Legislation:

The Alberni-Clayoquot Regional Hospital District is required by Section 23 of the Hospital District Act to adopt an annual budget by March 31 of each year.

Options:

If any amendments are required they should be made during second reading.
