### PORT ALBERNI RCMP DETACHMENT MONTHLY REPORT



This report represents the policing activities undertaken by the Port Alberni RCMP Detachment during February 2016. I have included an update on policing activities thus far in 2016 and a comparator to previous years.

The following represents some of the calls for services received, investigations undertaken and activities of the RCMP during the month.

- Officers received and responded to 786 calls for service, of these 671 were within the City of Port Alberni.
- After a prolonged and in-depth investigation charges were laid in the 2012 homicide of Mervin Hankins
- The Port Alberni Aboriginal policing unit has undertaken a number of initiatives:
  - Substance Abuse: Steve Story 'Re-boot'. This film is a documentary that connects substance abuse, from small communities to the Vancouver Downtown Eastside. Local youth were taken to the Vancouver Film School to see the filmmaking process and see the effects of substance abuse
  - Youth: the You-tube 'Kid President' video was used to open up discussion on bullying and how students can resolve bullying, 'End Gang Life' was presented to the USMA youth council
  - Culture Share is a program designed to prevent racism and to give students tools to deal with racism and cultural based bullying. The program has been delivered to all but one grade seven class at E.J. Dunn School.
  - DARE program has been delivered at Bamfield Community School, Maquinna Elementary and Haahuupayak.
  - Traffic enforcement through the use of education (articles and speed board) and radar enforcement
- This will be my final report to as a result of my transfer. The process to select a new Officer in Charge is underway and a replacement will be named in due course.

Port Alberni RCMP's 2015/16 Annual Performance Plan will focus on:

- Crime Reduction: Reduce the impact and prevalence of crime
- Mental Health: Increase awareness and decrease the impact of mental health in calls for service
- Visibility/engagement: Engagement with community and patrols
- Traffic: Increased road safety through focus on Provincial traffic offences and impaired driving








## Substance use: Mortality and Morbidity













## Alcohol Use









## Annual per capita Alcohol Consumption, Island Health - 5 Year Average from 2010 to 2014

#### Consumption driven by location of purchase





## The Changing Street Environment

- Fentanyl has become more available in last 3 years.
- Effect comparable to heroin may be longer lasting.
- Most product 'imported' not medical diversion.
- Higher concentration allows for smaller weights to be smuggled.
- Cheaper.
- Added issue: Poly pharmacy with many street supplies including narcotics and stimulants.





## Longer Term Needs

- Effective prevention of drug use and addiction.
  - School/university programming
- Early intervention activities
  - Access to peer support/counselling
- Major policy shifts.
  - Address negative impacts of underground economy
  - Access for users to test drug product
- Safer consumption sites.
- Increased access to detox and treatment programs. Treatment effectiveness low and best setting unclear
  - Current 12 detox beds for whole of Central Island 2-3 wk wait (Nanaimo)
  - 500 beds initiative
  - Rehab expensive
- Health professionals with more addiction training.
- Increased access to opiate substitution (methadone).



## Marijuana

- Not a special case.
- Special only in regulatory environment changing.

 Many issues that local governments may wish to consider.





## Issues

- Few proven health benefits, some health risks. Risk:benefit akin to alcohol.
- "Dispensaries" can be regulated to some extent by local government, but are not authorized by Health Canada – that may change. Product currently not monitored for quality.
- Authorized growers/dispensors need only advise local governments, but are not required to obtain approval.



## Housing as a Solution



- Good evidence of value
  - Local governments have significant influence.
  - Draft Port Alberni Housing and Homeless Plan – next steps?



- Need for diverse options
  - Detox, transition housing,
     collective supported environments.











# Standardized Rate of Drug Hospitalizations and Deaths by LHA, Island and BC












# Substance Use Trend



Dear Chair Osborne and Board:

We wish to thank you for your previous support of our proposed highway linking the communities on the Sea to Sky with central and northern Vancouver Island. A copy of your letter of support is attached.

2015 was a year of major achievement for us, as described in the attached summary. We are finally getting serious attention from the Ministry of Transportation and senior Government officials, in the form of the study being undertaken by Binnie, the Vancouver civil engineering consultant.

The ferry and transportation issues of the central coast have thus moved to the forefront, and what once seemed an impossible dream – something that would "never happen in my lifetime" – is now one of two real possibilities.

The first is a road between the Lower Sunshine Coast and the Lower Mainland that would replace the ferry between Langdale and Horseshoe Bay.

The second is our "third crossing" road between the Island and the interior, a truly transprovincial undertaking that would give the Province the biggest bang for its buck.

To refresh your memory of it, this highway would connect traffic from the Island and Interior communities via the Comox to Powell River ferry. Forty-two kilometres of new road and 131 of improved logging roads would be all that's required. We hope and expect that Binnie will confirm our estimate that the Provincial share of the costs would be fully offset by savings at BC Ferries and a toll, bringing the net cost to the Province to zero. I'll say that again: *zero*. The bonus is that this new stretch of pavement will also connect with the Lower Mainland.

The positive implications for Alberni Clayoquot are obvious.

Although commissioning of this study was a breakthrough, it puts the pressure on us to sell the vision to the public at large, to make it absolutely clear to the Province that your region, ours, and all the others, want this road, and let there be no doubt about it!

This will take a lot of time and effort, which the Society's Officers and advocates are fully prepared to devote to it, but we must have financial support to make that happen.

Our budget increased by 600% to \$3,300 in fiscal 2015. This year, as we close in on our objective, our level of activity will increase yet again, by 400% to \$13,000.

We will need to make forays into the cities, towns and regional districts through which this highway would pass, both in the interior and on the big island, and are thus hoping that Alberni Clayoquot will consider making a financial contribution toward the costs of meeting those needs – perhaps \$500 or so, but whatever you feel you can afford.

Attached please find the record of our recent accomplishments and objectives for the coming year. I'm available to discuss any questions you may have.

# MAJOR RECENT ACCOMPLISHMENTS

After much campaigning by ourselves and others, Binnie & Associates, consulting civil engineers, have been retained by the Ministry of Transportation and Infrastructure to conduct a study of the feasibility, cost and benefits of building road links between the Sunshine Coasts and the lower mainland. The budget for the study is \$250,000 and the report is expected this coming November. The Third Crossing proposal will be considered and we will have input.

Our cost estimates for the Howe Sound/Langdale ferry solution have been pegged at \$400 million; for the Third Crossing proposal, \$600 million – a total of \$1 billion for both. The federal share (1/3) leaves \$667 million to be raised by the Province. Offsetting savings at BC Ferries will bring BC's net BC cost to zero.

Several petitions, polls and surveys have been conducted by us and others. Support for the Highway is overwhelming, running at 80 – 90%.

"The underlying economic argument is that ferries will be expensive until the end of time, so fixed alternatives, even with tolls, might work out to be more economical. The underlying political dynamic is that of an ambitious transportation minister who's familiar with how blacktop gambles in B.C.—such as the Coquihalla Highway—can pay off.

Between now and decision day, we intend to:

- 1. Develop overwhelming public support for *our* highway.
- 2. Persuade Binnie to include a statement in their study that there are related matters beyond the existing terms of reference that also need study. (The terms of reference provide for that.)
- 3. Prepare to address the report's findings and conclusions.
- 4. Lobby the Government keeping both the economic argument and the political dynamic front and centre in the minds of everyone involved in that decision, so that they do the right thing not only for the lower coast but for the whole Province.

Re: My experience at West Cast General Hospital

On February 20 my wife drove me to the emergency wing of West Coast General Hospital. Where I had my Gall Bladder removed in an emergency procedure. It is what happened next that distresses me so much.

I was moved five times in four days. The first room, if you call it that, was an alcove off the working offices for the nurses. I did have a room for two nights and then I was subjected to the most humiliating and degrading sequence of moves. I was put into a stall where I was only separated by curtains from the person next to me, where there is no nearby wash room, where there is no place to put your personal belongings, where the lights are on twenty four hours per day. It was more stressful than an environment for recovery. I also lost personal belongings. I see this as an insult to me and to the thousands of forest workers who worked in the local mills and in the bush. We are <u>fifty year</u> tax payers and we deserve better than is. We have contributed to our community and to the province for all of our working careers and this is what we get in return.

I want to be clear, that I am talking about VIHA and the administration not the doctors and nurses. The staff worked very hard at their jobs and provided a service the best they could under the circumstances.

At this point in time West Coast General has a wing that is shut down, there a possible place for more beds in rooms. <u>The community needs and deserves more beds, in rooms.</u>

Dear Mayor and Council; Chair and Board:

I write to all UBCM members today in regard to UBCM resolution 2015-B111: National Inquiry on Missing and Murdered Aboriginal Women, which was considered and endorsed at the 2015 UBCM Convention. This letter provides an update on action taken in response to this resolution, and encourages member engagement in response to the severe and widespread violence faced by Indigenous women and girls in BC communities. The resolution reads as follows:

WHEREAS indigenous women and girls in Canada have been murdered or have gone missing at a rate four times higher than non-indigenous women, despite aboriginal women constituting less than five per cent of the Canadian population;

AND WHEREAS the homicide rate in the past decade is roughly seven time higher for indigenous women and girls than for all other women and girls in Canada:

Therefore be it resolved that UBCM request that the federal government convene a national inquiry into the widespread and severe violence faced by indigenous women and girls in Canada;

And be it further resolved that UBCM encourage their member local governments to work together, in collaboration with indigenous women's organizations, to institute a comprehensive response to the widespread and severe violence faced by indigenous women and girls.

The resolution requests that UBCM urge the federal government to convene a national inquiry regarding violence against Indigenous women and girls. On December 8<sup>th</sup>, 2015, Canada launched a National Inquiry into Missing and Murdered Indigenous Women and Girls. The inquiry is in response to the urging of many Indigenous families, communities and organizations, as well as non-governmental and international organizations, who called on Canada to take action, including through the Truth and Reconciliation Commission's Calls to Action.

Upon the request of Attorney General and Minister of Justice Suzanne Anton, UBCM provided feedback to inform the provincial government's response on the design of the inquiry process. The <u>UBCM submission</u> focused on the federal government's pre-inquiry design <u>discussion guide</u> questions, including National Inquiry leadership and participation, key issues, and how best to ensure concrete and practical recommendations. It expresses a desire to support and stand with those who deserve justice and healing; emphasizes associated UBCM policy; and conveys the role of local governments in ensuring safety and wellbeing in BC communities. Based on this submission and subsequent discussion with Minister Anton, feedback was also submitted directly to the federal Pre-Inquiry Secretariat.

The resolution also directs UBCM to encourage member collaboration, and cooperation with Indigenous women's organizations, in order to institute a comprehensive response to the severe violence faced by Indigenous women and girls. In many instances local governments already have established relationships with local Indigenous organizations; for those who are looking to make initial contact, a listing of Indigenous women's organizations is attached. This list provides only an overview of active organizations, and is not intended to be comprehensive, but may provide a stepping-stone for communities looking to establish a connection. By strengthening relationships with Indigenous organizations and service providers it may be possible to better support and promote work already underway, and identify opportunities for future partnership.

As leaders and protective service providers, local governments are dedicated to building and fostering safe communities that are free from violence. I sincerely thank you for considering how your local government might engage during the national inquiry process, and with Indigenous organizations within your community. UBCM will continue to engage in the inquiry process as it progresses, and inform members of opportunities to provide further feedback or participate in proceedings.

Thank you for your correspondence of December 17, 2015, concerning the conservation of eulachon.

I understand that this is an important issue to the British Columbia shrimp trawl industry. Fisheries and Oceans Canada (DFO) is always interested in measures that can reduce the bycatch of non-target species, particularly those with depressed stocks like eulachon that are being considered for listing under Canada's *Species at Risk Act*. DFO officials have met with the shrimp trawl commercial harvesters to explore ways to determine the effectiveness of the use of lights to reduce eulachon bycatch in the British Columbia shrimp fishery.

In 2015, the Department issued an experimental licence to the British Columbia shrimp trawl industry to conduct some initial trials with lights. DFO is also in the process of initiating a review of the Oregon study to determine if the results are applicable to the British Columbia shrimp fishery. The Department has also agreed to expand the issuance of experimental licences again this year to fleet members to allow those trials to continue. It is anticipated that the results of this evaluation will be completed by the summer of 2016.

In the meantime, DFO officials will continue to engage with the shrimp trawl harvesters on this issue. **Subject:** Fire Protection Service Agreement Long Beach Airport

### **Recommendation:**

THAT the Alberni-Clayoquot Regional District Board of Directors enters into the Fire Protection Services Agreement as presented with the District of Tofino for the Tofino Volunteer Fire Department to provide structural firefighting to the Long Beach Airport for a fee of \$1.00 for a one year term AND FURTHER the Vice-Chairperson and Chief Administrative Officer be authorized to execute the Fire Protection Service Agreement for the Long Beach Airport.

### **Desired Outcome:**

To enter into an agreement in order for the District of Tofino to provide structural fire protection services to the Long Beach Airport in conjunction with the District of Ucluelet.

#### **Background:**

The District of Tofino has been providing structural fire protection to the Long Beach Airport under an outdated agreement with Parks Canada (previous owner of the Airport) which expired on March 10, 2015. The original agreement with Parks Canada dates back to 1999. When the Regional District took over ownership of the Airport, they inherited all active agreements for the Airport.

ACRD and District of Tofino staff has been working on an updated fire protection service agreement (attached) for the past year. If approved, the new aid agreement will enable the Tofino Volunteer Fire Department to be dispatched to the airport for structure and airplane fires. This agreement matches the commitment that the District of Ucluelet has made with the ACRD in responding to the Long Beach Airport. The Agreement is for a one year term, with the ability to extend for an additional one year term up to a maximum of 10 years.

Tofino Council passed a resolution endorsing the agreement at their meeting on February 23, 2016. Regional District staff recommends that the ACRD Board enters into the one year Agreement with the District of Tofino as presented.

#### Time Requirements – Staff & Elected Officials:

Minimal time required to enter into the agreement.

## **Financial:**

\$1.00 for a one year term. In addition, the Regional District shall replace any materials used by the Tofino Fire Department in providing structural firefighting services to the Airport.

## **Policy or Legislation:**

The *Local Government Act* and *Community Charter* gives Regional Districts' the authority to enter into service agreements with neighbouring local governments.

# WHEREAS:

- A. The District of Tofino is a municipal corporation and local government under the *Community Charter* and the *Local Government Act* of British Columbia;
- B. The District of Tofino has established fire and emergency response as a municipal service to the land area within its boundaries, operated through the Tofino Volunteer Fire Department;
- C. The Regional District owns and operates the Long Beach Airport (CYAZ) located approximately 11 kilometers southeast of the District of Tofino;
- D. The Regional District has requested and the District of Tofino is prepared to provide firefighting services to the Long Beach Airport , subject to the terms and conditions contained in this Agreement;
- E. The Regional District Board of Directors has approved this Agreement and its resolution is attached as Schedule "A" to this Agreement;
- F. The Mayor and Council of the District of Tofino have approved this Agreement by a Council Resolution, attached as Schedule "A" to this Agreement.

**NOW THEREFORE** in consideration of the covenants herein contained and for other good and valuable consideration the receipt and sufficiency of which is hereby acknowledged by both parties, the Regional District and the District of Tofino, do hereby covenant and agree each with the other as follows:

#### 1.0 DEFINITIONS

- 1.1 For the purposes of this Agreement, the following definitions shall apply:
  - "Airport Emergency Response Plan" ("ERP") means the document which contains roles and responsibilities for a multi jurisdiction response to occurrences on airport property. The procedures contained in the ERP are published to provide guidance before, during and after any emergency involving aircraft, structures and other events affecting the operations of the airport;
  - "Fire Chief" means the person who is the head of the Tofino Volunteer Fire Department or that person's lawfully appointed designate;
  - "Fire Department" means the Tofino Volunteer Fire Department;
  - "Fire Service Area" means that area identified on Schedule "B" to this Agreement;
  - "Airport" means the Long Beach Airport (CYAZ);
  - "Senior Officer" means the highest-ranking Officer after the Fire Chief, or the most senior firefighter to arrive on the scene;
  - "Structural Firefighting Service" means emergency firefighting service responding to structural fires only for the purpose of rescue, fire control, and property conservation.

#### 2.0 WATER SUPPLY

2.1 The District of Tofino, its elected officials and appointed officers, employees and volunteers shall not be responsible for any loss occurring as a result of the inability to fight any fire emergency on the Airport due to insufficient supply of water, insufficient water pressure or any other reason outside the Regional District's control.

#### 3.0 EXTENT OF SERVICE

- 3.1 The District of Tofino, through the Tofino Volunteer Fire Department, shall provide to the Regional District, on the terms and conditions of this Agreement, Structural Firefighting Services to the Airport as of the date of this Agreement, within the Fire Service Area.
- 3.2 Upon the application of this agreement, , the Fire Department shall attend an emergency on the Fire Service Area and provide Structural firefighting services as needed.
- 3.3 Subject to this Agreement, the District of Tofino shall provide the same quantity and quality of Structural Firefighting Services required by this Agreement as such services are provided by the District of Tofino to residents of the District of Tofino generally.
- 3.4 This Agreement shall not be interpreted to create any greater standard of care or liability on the part of the District of Tofino in respect of the supply of fire protection services to the Airport than that which applies to the supply of such services to inhabitants of District of Tofino. Nothing in this Agreement shall require the District of Tofino to provide a fire service under this Agreement higher than the level of fire protection service provided to the District of Tofino. The Airport Emergency Response Plan (ERP) shall be used as a guide in operations.
- 3.5 Notwithstanding any other provision in this Agreement, the parties acknowledge and agree that the distance between the Airport and the Tofino Fire Hall will result in longer response times than the average response time within the District of Tofino. The parties acknowledge and agree that the Tofino Volunteer Fire Department has limited resources for fighting fires including limited personnel, training and equipment. Accordingly, it is acknowledged that a reduced level of services in respect of response time and overall fire protection services will be provided to the Airport.
- 3.6 Notwithstanding any other provision in this Agreement, the parties acknowledge and agree that the Tofino Volunteer Fire Department has limited resources to fight aircraft fires. The department will fight fires using equipment and apparatus designed for use for combating Structural Firefighting.
- 3.7 Nothing in this Agreement requires the Fire Chief of the Tofino Volunteer Fire Department to deploy firefighting personnel, apparatus, and equipment to the Airport, where the Fire Chief or his/her Senior Officer has determined that they are either unavailable or are required to provide fire protection within the District of Tofino fire service area. The Airport agrees that in the event of the failure of the Fire Department to respond to a call for firefighting assistance, or where the Fire Department is required to withdraw equipment and personnel to attend to a fire or emergency in the District of Tofino, the Regional District shall not make any claim of liability against the City and hereby waives any claim it may have arising from such failure to respond or withdrawal.

#### 4.0 NATURE OF SERVICE

- 4.1 The District of Tofino shall provide the firefighting service on a twenty-four hour on call basis from the Fire Hall, utilizing the manpower and equipment available at the time of notification of a fire.
- 4.2 The Airport shall give the Fire Department unrestricted vehicle access to the none airside portions of the airport within the Fire Service Area for the purpose of responding to and suppressing fires and other emergency incidents. Access to the restricted airside portions of the airport will be under the guidance of the On Scene Controller / unified command in accordance with the Long Beach Airport Emergency Response Plan.

#### 5.0 INDEMNITY AND INSURANCE

- 5.1 The Airport shall afford the District of Tofino and its employees and agents the same protection from liability as is provided under the Community Charter and the Local Government Act in respect of the District of Tofino's activities elsewhere in the District of Tofino and, without restricting the generality of the foregoing, shall defend, indemnify, and save harmless the District of Tofino from and against any and all claims, demands, actions, causes of action, losses, damages, costs, liabilities and expenses (including legal fees and costs on a solicitor and own client basis) of whatever kind or character on account of any actual or alleged loss, injury or damage to any person or to any property arising out of or in connection with the provision of or failure to provide the Structural Firefighting Services as required herein, if and to the extent that the District of Tofino, its employees or agents would have otherwise been excused from liability for such loss, injury or damage pursuant to the terms of the Community Charter and the Local Government Act but for the fact that such provision or failure to provide the Structural Firefighting Services is in respect of lands and occupiers of lands on the Fire Service Area.
- 5.2 Without limiting the preceding paragraph, the Airport shall release and indemnify and save the District of Tofino harmless from and against any and all claims, demands, actions, causes of action, losses, damages, costs, liabilities, and expenses (including legal fees and costs on a solicitor and own client basis) arising as a result of the District of Tofino's failure to respond to a call for Structural Firefighting Services, the District of Tofino withdrawing Structural Firefighting Services as set out in paragraph 3.7 above, or the District of Tofino suspending or terminating the provision of Structural Firefighting Services under this Agreement.

5.2 Each party to this Agreement shall maintain, throughout the Term, comprehensive general liability insurance, motor vehicle insurance, and Workers' Compensation coverage for its own personnel. All policies of insurance required to be taken out by the Airport shall name the District of Tofino as an additional insured and the Airport shall, prior to the commencement of this Agreement and thereafter promptly upon request by the District of Tofino, provide the District of Tofino with certificates of insurance confirming the placement and maintenance of the required insurance.

#### 6.0 FEES

- 6.1 The annual fee for fire protection services provided by the District of Tofino under this Agreement shall be \$1 (one dollar).
- 6.2 The Airport shall replace any materials used by the Fire Department in providing the Structural Firefighting Services to the Airport, including firefighting foam and other operational items provided by the Fire Department.

#### 7.0 COST OF ADDITIONAL AID

7.1 The Regional District agrees to pay the full cost of any additional firefighting manpower or equipment from another jurisdiction outside the Regional District that the Regional District considers necessary to assist with an emergency situation on the Airport.

#### 8.0 RIGHTS RESERVED

8.1 Nothing contained or implied herein shall prejudice or affect the rights and powers of the District of Tofino in the exercise of its functions under any public or private statutes, bylaws, orders or regulations, all of which may be fully and effectively exercised in relation to the Fire Department and the fire protection services provided hereunder and any other function of the District of Tofino as if this Agreement had not been executed and delivered by the parties and the interpretation of this Agreement shall be subject to and consistent with statutory restrictions imposed on the District of Tofino under the *Local Government Act* and the *Community Charter*.

#### 9.0 TERM OF AGREEMENT

9.1 This Agreement shall come into force as of the date of its execution by all parties and shall continue in force for 1 year or until earlier terminated as provided for in

this Agreement. Upon agreement of the parties, this Agreement may be extended for a further term of 1 additional year, to a maximum of 10 years.

#### 10.0 ASSIGNMENT

10.1 This Agreement shall not be assigned by any of the parties hereto except with the prior written consent of the others, which consent shall not be unreasonably withheld.

#### 11.0 TIME

11.1 Time shall be of the essence of this Agreement.

#### 12.0 INTERPRETATION

12.1 No provision of this Agreement shall be construed to create a partnership or joint venture relationship, an employer-employee relationship a landlord-tenant, or a principal-agent relationship.

#### 13.0 HEADINGS

13.1 The headings in this Agreement are inserted for convenience and reference only and in no way define, limit or enlarge the scope or meaning of this Agreement or any provision of it.

#### 14.0 WAIVER

14.1 The waiver by a party of any failure on the part of the other party to perform in accordance with any of the terms or conditions of this Agreement is not to be construed as a waiver of any future or continuing failure, whether similar or dissimilar.

#### 15.0 LANGUAGE

15.1 Wherever the singular, masculine and neuter are used throughout this Agreement, the same is to be construed as meaning the plural or the feminine or the body corporate or politic as the context so requires.

#### 16.0 BINDING EFFECT

16.1 This Agreement will ensure to the benefit of and <u>be</u> binding upon the parties hereto and their respective successors and permitted assignees.

#### 17.0 TERMINATION BY THE DISTRICT of TOFINO

17.1 The District of Tofino may terminate this Agreement at any time upon giving 90 days' notice in writing to the Regional District.

#### 18.0 TERMINATION BY THE REGIONAL DISTRICT

18.1 The Regional District may terminate this Agreement at any time upon giving 90 days' notice in writing to the District of Tofino.

#### 19.0 NOTICE

19.1 It is hereby mutually agreed that:

any notice required to be given under this Agreement will be deemed to be sufficiently given:

- (i) if delivered, at the time of delivery; and
- (ii) if mailed from any government post office in the Province of British Columbia by prepaid registered mail addressed as follows:

if to the Regional District:

if to the District of Tofino:

121 3rd Street PO Box 9 Tofino, BC, V0R 2Z0

Unless otherwise specified herein, any notice required to be given under this Agreement by any party will be deemed to have been given if mailed by prepaid registered mail, or sent by facsimile transmission, or delivered to the address of the other party set forth on the first page of this Agreement or at such other address as the other party may from time to time direct in writing, and any such notice will be deemed to have been received if mailed or faxed, 72 hours after the time of mailing or faxing and, if delivered, upon the date of delivery. If normal mail service or facsimile service is interrupted by strike, slow down, force majeure or other cause, then a notice sent by the impaired means of

communication will not be deemed to be received until actually received, and the party sending the notice must utilize any other such services which have not been so interrupted or must deliver such notice in order to ensure prompt receipt thereof.

#### 20.0 DISPUTE RESOLUTION

- 20.1 If a dispute relating to this Agreement should arise, and the Parties cannot settle the dispute through negotiation, then the Parties must attempt in good faith to resolve the dispute through mediation. If mediation is unsuccessful, the parties may submit the dispute to binding arbitration pursuant to the *Commercial Arbitration Act* (British Columbia).
- 20.2 If any dispute is referred to mediation or to an arbitrator appointed under the *Commercial Arbitration Act*, the costs of the mediation or arbitration shall be borne equally by the parties involved in the dispute. The parties agree that in the event of arbitration, a single arbitrator shall be appointed in lieu of a panel.

#### 21.0 ENTIRE AGREEMENT

- 21.1 The whole agreement between the parties is set forth in this document and no representations, warranties or conditions, express or implied, have been made other than those expressed.
- 21.2 This Agreement may be amended from time to time upon terms and conditions mutually acceptable to the District of Tofino and the Regional District only if the amendments are in writing and executed by the parties hereto.



#### **Recommendation:**

That the Alberni-Clayoquot Regional District Board of Directors extend the contract with Marcie DeWitt, Alberni-Clayoquot Health Network Coordinator for an additional two (2) term ending February 28, 2018 in the amount of \$80,000.00 per year including GST, travel and expenses.

#### **Desired Outcome:**

To extend the current contract with the Alberni-Clayoquot Health Network Coordinator for an additional two (2) years in order to continue to support the Alberni-Clayoquot Health Network.

#### Background:

In the spring of 2011, the Alberni-Clayoquot Regional Hospital District formed the Alberni-Clayoquot Health Network (ACHN) with funding from the Vancouver Island Health Authority (Island Health). The ACHN is a group committed to improving the quality of health care decisions, health services and well being in the Alberni-Clayoquot region. The Network serves as an open forum for discussion on the determinants of health, the identification of health service priorities and community and health services planning and development.

The ACHN has been supported by a Coordinator since 2012. The Coordinator provides leadership and coordination services to the ACHN and Table of Partners and ensures the Network is meeting their mandate and strategic priorities. The Coordinator oversees operations of the Network and incorporates the vision, mission, purpose, values, goals and objectives of the Network.

Ms. Dewitt has been in the Coordinator position through a one year contract with the Regional District which expired on February 29, 2016. Over the past year, Ms. Dewitt has been instrumental in moving the Network forward on several of their strategic priorities. Accomplishments in 2015 include: Strategic Plan update, development of a communications strategy, transportation action tables formed and the development of the Wheels for Wellness Pilot Project on the West Coast. A copy of the 2015 annual report is attached.

Over the past three month the Network has been engaged in:

- Planning a Collective Impact gathering with partners from all over Vancouver Island
- Planning a workshop to inform the formation of a Poverty Reduction Strategy. We have been working closely with the MP and MLA on poverty reduction conversations
- · Working with the AVCSI and other community partners on housing
- Convening the Transportation Action Table and West Coast Working group on Wheels for Wellness as well as a regional transportation assets mapping project

The ACHN Table of Partners met on March 16<sup>th</sup> and recommends the ACRD Board of Directors extend the contract for services with Ms. DeWitt for an additional two (2) year term. The current contract allows for a contract extension.

#### Time Requirements - Staff & Elected Officials:

Minimal time required to extend the current contract.

#### **Financial:**

Island Health has committed to a grant of \$80,000.00 per year for three years commencing November 2015 to support the ACHN Coordinator position. The new funding provided will provide the means to cover this position until the term ending February 28, 2018.

The ACRD's purchasing policy was followed.





Festival Project Details: The Carving on the Edge Festival 2016

The themes for this year will be centred around Tla-o-qui-aht teachings, history, community, and vision. Through discussions with the board of directors and participating carvers we have decided to take this year to properly acknowledge the Tla-o-qui-aht Nation as the host community for the festival. Throughout our planning we will continue to meet with chiefs, leaders, and cultural knowledge keepers within Tla-o-qui-aht to fully integrate the proper protocols and logistical support to make this acknowledgement possible.

#### Warm up Pre-festival Event

Carving Demonstrations for Families - Tofino's Village Green, September 10, 10am - 2pm, Free admission Estimated Attendance: 100 plus

Robinson Cook will be on site with a large carving in progress. Children and youth will have the opportunity to carve on his piece with him under one-on-one supervision. Dan Law will also be offering drop in printmaking for all ages with small foam, lino or rubber blocks depending on ability. In partnership with Tofino's Parks and Recreation, this will be offered at the local Saturday market.

Main Festival Dates: September 12-22, 2016 Location: Shore Pier Events Building (on the water) 368 Main Street, Tofino

Opening Ceremonies and Gallery Reception for the Carving on the Edge Art Show September 14, 7pm, Free admission Estimated Attendance: 80 plus

The festival's opening involves traditional welcoming ceremonies from the Tla-o-qui-aht First Nations that include drumming, singing and dancing. Local First Nations' also share stories and cultural histories related to the long history of carving. Festival organizers acknowledge the organizations and businesses who participate in supporting the festival. Featured artists will be in attendance. Food and refreshments are served.

#### Carving on the Edge Art Show September 14-22, Open Daily from 10-5, Free admission Estimated Attendance: 2000 plus

The two-week carving arts show will showcase traditional and contemporary west coast carving arts. The carving arts show involves 30 - 50 artists from British Columbia and include both master and emerging artists. First Nations and non-First Nations artists will show and sell their work; each year the festival showcases new works by the artists. The Art Show provides incentive for carvers to attend the festival by providing an opportunity for sales, and to share their craft and traditional teachings to the public. The Carving Festival takes 25% of the sales to cover exhibition costs, promotion and marketing.

The Virtual Archive' Multi-media installation also hosted in the gallery space A vast collection of Tla-o-qui-aht ornamental and ceremonial pieces are currently being held in museums across the world. In recent years there has been a big shift towards reconnecting these pieces back to their home communities and many have made their collections available online. Many master carvers have invested in travelling to study these works but most community members cannot afford to and/or experience barriers to technology. We would like to hire someone to research and collect information on the Tla-o-qui-aht and Nuu-chah-nulth work currently being held and prepare a multi-media display to give access to our local community and visitors. This would be done under the guidance of master carvers to ensure the best accuracy of information. We feel that this could be a really unique way to stimulate discussion about Tla-o-qui-aht traditional form and design.

Workshops are hosted over the festival weekend: September 16, 17 & 18, scheduled in slots between 10-5 daily

Estimated Attendance: 400 plus

The workshop coordinator will be responsible for setting up scheduling and sign ups. For most of our workshop offerings we have decided to shift from offering free workshops to a subsidized suggested donation to ensure that participants are fully committed and engaged. Volunteering in exchange for free workshop vouchers is also strongly encouraged to ensure accessibility for everyone who is keen to participate! Bursaries for young carvers who show that they are keen to learn will also be made available. We will be presenting **6 different workshops.** How many times each will be offered over the span of the weekend will be determined by sign ups and expressed interest.

#### Bentwood box workshop with Joe Martin

Participants will learn the techniques of steaming and finishing their own box Each session will be a full day workshop, 6-8 participants, \$180

#### Relief printmaking with Dan Law

- **Woodblock printmaking for intermediate printers:** utilize handmade locally salvaged yellow cedar planks, high quality carving tools, archival quality paper & ink 3-4 hrs, 20 participants suggested donation \$20-25
- Drop in printmaking for all ages: using foam, lino or rubber blocks depending on tool ability, lino carving tools, artist quality paper & ink

We will make some simple blocks of alder and other offcuts available for use for those who may not have access to wood but carvers are responsible for bringing and maintaining their own tools (Kestral Tools will have some tools for sale on site). Coffee, tea and light snacks will be served for the carvers.

#### Traditional Dugout Canoe Tours with T'ashii Paddle School Friday, September 16 and Saturday, September 17, (3 departures daily) Estimated participants: 60, Admission: By donation

T'Ashii Paddle School will offer 45 minute cultural tours via a hand-carved traditional dugout canoe, made by Joe Martin. Using hand-carved paddles, Tsimka Martin will share stories of the land and water from the 35-foot canoe that she steers with 10 guest paddlers. A truly memorable event of the festival.

An Evening of Tla-o-qui-aht Culture: Friday September 16, 7pm Shore Pier Events Building (capacity 200)

#### Tla-o-qui-aht Language as the key to Our Ancestral Way of Being Keynote Speaker: Gisele Martin

Local Nuu-chah-nulth language activist, cultural educator and wilderness guide, Gisele Martin grew up in and around her father's traditional dugout canoes. For many years Gisele founded and ran her own canoe tour business, which she used to share the wealth of her cultural knowledge with the world. In recent years she has shifted her focus towards language revitalization and has become the youngest fluent speaker in Tla-o-qui-aht. She now uses her deep connection to the land and waters to develop meaningful programming for children and youth. Gisele will be sharing insights into the traditional Tla-o-qui-aht carvers values and worldview using language and storytelling.

#### Film Screening: Nuucaanûułathin "We Are Nuu-chah-nulth" (1hr)

Filmmakers John Rampanen and Nitanis Desjarlais will be available for Q & A 'We Are Nuu-chah-nulth' is a thoughtful glimpse into the rich and diverse history of the Nuu-chah-nulth people. Elements of traditional story telling are woven throughout a visually artistic and engaging narrative that captures a challenging chapter of history along the western coast of Canada. This documentary highlights key moments and insights into the Nuu-chah-nulth way of life.

## Evening of performance with Guest First Nations: Saturday September 17, 7pm Shore Pier Events Building (capacity 200)

For our second evening presentation we will be hosting guests from outside Tla-o-qui-aht. We are hoping to welcome back the Kwakuitl and there are some other communities we are in conversation with that we would love to host. This evening is not confirmed at this time.

#### Youth Showcase - performance and presentation

We are planning to put aside an evening for local youth to design their own event. The details will be coordinated under the direction of the youth participants.

### Master Carvers Session: Sunday September 18, 2pm Estimated Attendance: 40 plus

Sunday afternoon is the time when the carvers who have gathered get a chance to network and share skills. It is important to us to nurture the artists professionally and creatively.

Tla-o-qui-aht Traditional Form and Style with Joe David

Through the Virtual Archive we will have a large body of Tla-o-qui-aht work on display. Master carver Joe David will be making a focused presentation on traditional Tla-o-qui-aht style and form geared towards other carvers.

Granting Workshop with the First People's Culture Council

FPCC manages a few different funding streams that support First Nation's artists and community projects. They are interested in building relationships with our west coast carving community and will be offering a workshop on grant writing, project planning and some modules from The Art of Managing Your Career.

• Carvers Talking Circle and Feast, 5pm

This is our opportunity to debrief the festival with our carving community and determine the direction of next year's festival. Food will be served and shared so that as we are digesting as we are listening to each other as it is in Tla-o-qui-aht custom.

Note: If the Board has any further amendments to the Financial Plan the following steps will be required **prior** to giving third reading and adoption of Bylaw F1125:

- a. Motion to rescind second reading of Bylaw F1125
- b. Motion with amendments to the Financial Plan
- c. Motion giving second reading as amended

#### **Summary:**

Attached separately is the draft for third reading and adoption of the Financial Plan for 2016-2020 for the Regional District that will be considered at the March 23, 2016 Board of Directors meeting. This is the final stage of the 2016 budgeting process and this draft has not only been presented to the Board but has also been presented to the public in various meetings throughout the Regional District. Presentations have been made to the councils of the City of Port Alberni as well as public meetings in the electoral areas of Bamfield, Sproat Lake and Beaver Creek. A comparison of the residential tax rates has also been provided for your information at the end of this memo.

At second reading on March 16<sup>th</sup> the following amendments were made to the 2016-2020 Financial Plan:

Alberni Valley Regional Water Proposed Service - Page 36

Reduce Line 3 by \$10,000, from \$52,178 to \$42,178 Reduce Line 9 by \$10,000, from \$22,000 to \$12,000

Cherry Creek Community Parks Service – Page 100

Increase Line 2 by \$12,500, from \$7,500 to \$20,000 Increase Line 5 by \$12,500, from \$7,000 to \$19,500

The Wheels for Wellness grant from the Area "C" Long Beach is conditional based on the organization meeting the requirements for the funding and this is the intention of the area director for this grant-in-aid. If the funding requirements are not met the funds tax requisitioned would remain with the Area "C" grant — in-aid for future allocations for Area"C".

With the above amendments made before second reading, the total tax requisition and parcel taxes for 2016 are currently set at \$7.29 million, which is 8.56% higher than the prior year when combined with the Alberni-Clayoquot Regional Hospital District. The AVRA expansion has the largest impact on the overall increase for 2016 and if this service was not increased we would have seen a 2.60% increase overall. A comparison of the residential tax rates has also been provided for your information at the end of this memo for the regional district, also the tax rate summary for all services is attached.

#### **Policy/Legislation**

The *Local Government Act* requires the Regional District to adopt a 5 year Financial Plan on or before March 31<sup>st</sup> of each year.

#### **Development Variance DVE16003:**

Development variance of Section 200 – Schedule II – Bulk and Site Regulations of ACRD Zoning Bylaw No. 15 to reduce the required front yard setback and required side yard setback in the Rural (A2) District; front yard from 50 feet to 25 feet and side yard from 15 feet to 5 feet as shown on the site plan attached.

**Procedure:** Prior to the issuance of a development variance permit, the Board must first pass a resolution to consider issuing the permit. Staff then notifies neighbouring property owners and tenants to afford them the opportunity to make written or verbal submissions to the Board. At the subsequent meeting, the Board issues or denies the development variance permit.

#### **Observations:**

i. Status of Property: The 0.299 acre (1213.67 square meters) property is undeveloped and has some smaller trees.

#### ii. Services

- **a. Sewage Disposal**: A sewage disposal system will be designed by a Registered On-Site Wastewater Practitioner.
- **b.** Water Supply: Beaver Creek Water System.
- c. Fire Protection: Beaver Creek Volunteer Fire Department
- **d.** Access: The property fronts on both Maple Street and Compton Road.

#### iii. Existing Planning Policies Affecting the Site

- a. Agricultural Land Reserve: Not within the ALR.
- **b.** Official Community Plan: The property is designated "Residential Use" in the Beaver Creek OCP. This designation provides for residential use. The property is not within a development permit area.
- **c. Zoning**: The property is zoned Rural (A2) District which permits one single family dwelling, accessory uses and other rural uses such as agriculture.

The owners are applying for a development variance permit prior to starting construction. The lot is non-conforming is size and is irregularly shaped. The front yard variance will be off Maple Street and the side yard variance is the north property line.

The proposed layout would maintain all of the setbacks required by the Ministry of Transportation and Infrastructure, which is 15 feet from any road or lane.

The proposed construction will require a development variance to reduce the required front yard setback from 50 feet to 25 feet and the side yard setback from 15 feet to 5 feet on the north property line as shown on the attached site plan.

**Comments:** Staff recommends the Board proceed with the development variance. The subject property is a small non-conforming lot with a limited building site. The proposal is in keeping with the surrounding properties. By reducing the setbacks, the property owners will have greater flexibility in the development of their lot.





At the subsequent meeting, the Board issues or denies the Temporary Use Permit.

# **Observations:**

i. **Status of Property**: The subject property is 0.14 ha (0.34 ac) in area and is currently vacant with no improvements. The property was previously the site of the Stamp Falls General Store and single gas pump dating from the mid 1950s until the commercial operation was shut down in the mid 1990s. The store building, garage and attached dwelling were demolished and removed from the site in 1997 leaving the property vacant. The lot is level and cleared.

The current property owner hired Lewkowich Engineering Associates to prepare a Phase I Environmental Site Assessment dated October 2014. The assessment investigated the potential for soil, surface and groundwater contamination on the property and adjacent land. The report recommended that a Phase II investigation of the site would be required based on the historical presence of a vehicle garage, an underground gasoline tank and fuel pump infrastructure on the northern part of the site.

Lewkowich Engineering completed the Phase II Preliminary Site Investigation and prepared a report dated December 2014. The scope of this report was to investigate an area of potential concern near the previous fuel pump and underground fuel storage. The study included test pits and soil samples. After analyzing soil samples the report concludes that there is no significant contamination of the site or surroundings and that no further investigation or remediation would be required.

#### ii. Services

- **a. Sewage Disposal**: On-site sewage disposal. A new septic system would be designed and installed by a Registered On-Site Wastewater Practitioner as a condition of the building permit.
- b. Water Supply: Beaver Creek Water System.
- **c. Fire Protection**: Beaver Creek Volunteer Fire Department.
- d. Access: The property is accessed from Beaver Creek Road in a location with clear visibility and long sight lines. The site plan provided with the application shows a proposed 18 foot wide asphalt access road along the east property boundary. The plan also shows 7 designated parking spots along the north boundary adjacent to the road with 55 feet of clearance between the proposed building and the road right-of-way.

# iii. Existing Planning Policies Affecting the Site

- a. Agricultural Land Reserve: Not within the ALR.
- **b.** Official Community Plan: The Beaver Creek OCP designates the property as "Commercial Use". The Commercial Use objectives are to:
  - Facilitate the establishment and operation of small scale commercial development that is compatible with Beaver Creek's predominantly rural character (Objective 5.1.1); and
  - ii. Encourage tourism and other economic development opportunities (Objective 5.1.2).

Policy 5.2.3 states that the Regional District will support existing commercial enterprises as well as new enterprises that wish to establish a small scale, local service business in commercially designated areas outside the main transportation corridor.

Policy 3.2.10 allows a temporary use permit to be considered in appropriate areas in all land use designations, in accordance with the *Local Government Act*.

There are no Development Permit Areas that impact this property.

The proposed local commercial use complies with the policies of the Beaver Creek OCP and the issuance of a temporary use permit to allow the craft distillery is permitted in all OCP land use designations.

**c. Zoning**: The property is zoned Highway Commercial (C4) District. The C4 District provides for the accommodation of vehicular-oriented commercial uses of low intensity.

The proposed commercial use on this property would include a +/- 1,000 ft<sup>2</sup> commercial building that would house a small coffee shop with an area for small gifts and convenience items in one section and a small craft distilling operation in another section. The coffee shop would include a limited food menu and seating for 8 people. The micro distillery would include an area for sales of spirits on site as well as a small tasting area. The distillery may include a picnic area attached to the tasting area but will not include a lounge area or special event area. The intention is for customers to sample the spirits on site and then purchase the product and remove it from the premises. This will not be a primary drinking establishment.

The Tourist Commercial (C4) District permits food store and general merchandise store retail outlets provided the retail floor area does not exceed 2,000 ft<sup>2</sup> in floor area and also permits restaurants and similar uses. Food and beverage manufacturing industries are permitted in the Industrial Park (M1) District but there is no zone that specifically allows micro distillery or small scale craft distillery uses.

Under Section 493 of the Local Government Act, the Regional District may issue a Temporary Use Permit, by resolution, in areas where areas are designated in an Official Community Plan. A Temporary Use Permit may do one or more of the

#### following:

- i. Allow a use not permitted under the Zoning Bylaw;
- ii. Specify conditions under which the temporary use may be carried;
- iii. Allow and regulate the construction of buildings or structures in respect of the use for which the permit is issued.

Where a temporary use permit is designated in an OCP, the Regional District must give notice to the public in accordance with the requirements of the Act which includes notifying the neighbouring property owners and tenants, and publishing a notice in the newspaper.

The Temporary Use Permit is valid for up to 3 years and may be renewed by the Regional District once. After this time has expired the property owner must apply to rezone the property to allow for the continued use or discontinue the specified use.

The coffee shop and general merchandise/food store is a permitted use in the Tourist Commercial (C4) District and the temporary use permit application would allow for the operation of the craft distillery under the conditions set out in the permit.

# d. Temporary Use Permit:

Temporary Use Permit TUP15017 shall be subject to the following conditions:

- 1) This permit shall only be applicable to LOT A, DISTRICT LOT 101, ALBERNI DISTRICT, PLAN 7121.
- 2) This permit is issued for a craft distillery use.
- 3) Strict compliance with the requirements of a valid Manufacturer's License from the BC Liquor Control and Licensing Branch which may include a tasting room, retail sales of the product produced on-site and picnic area.
- 4) No lounge or special event area permitted on-site.
- 5) Operating hours of craft distillery tasting room and retail sales shall be no later than 8pm.
- 6) Annual production shall be no more than 15,000 L of distilled spirits per year.
- 7) This permit is valid for three (3) years from the date of execution.

#### **Comments:**

- 1. Planning Department staff have been investigating micro brewery, cidery, winery and distillery uses in the updated Zoning Bylaw. The applicant approached the Regional District with the idea to develop the commercial building on this property with the associated craft distillery. After reviewing the options, it was determined that the temporary use permit application would allow for the distillery use to be developed while the new Zoning Bylaw is still going through the update process. If the temporary use is compatible and appropriate, planning staff can investigate including it as a permitted use in the new zone that will impact this property or require a separate a rezoning application to allow the use on a more permanent basis.
- 2. The applicant is applying to the Liquor Control and Licensing Branch for a Manufacturer's License to allow for the distillery at the subject property. The Manufacturer's License allows for the production of distilled spirits as well as additional endorsements that would allow on-site sampling, retail sales, lounge and special event areas. The application process requires written confirmation from the Regional District that the site is zoned appropriately for a distillery and on-site retail store. There is no public input process required for the Manufacturer's License except where a lounge or special event area endorsement is applied for, which would be similar in process to the public input required for a Food Primary or Liquor Primary License for restaurants, bars, pubs, etc.

In 2013, the provincial government established two categories of distilleries in BC: "Commercial" and "Craft". To achieve the craft designation recognized by the province a distillery must produce no more than 50,000 litres of spirits per year and use 100% BC agricultural products to produce the alcohol from fermentation completed on-site by the distillery. The applicant will be setting out to achieve the craft distillery designation as recognized by the province although the annual production will be capped at 15,000 litres of spirits per year for the period of this temporary use permit.

3. While this property is fairly isolated from other commercial uses, it was kept as commercial through the 2013 update of the Beaver Creek Official Community Plan to allow for the return of local commercial uses in this neighbourhood. The coffee shop and food/general merchandise uses can be developed under the current zoning while the craft distillery use is intended to attract a broader commercial clientele to the area, specifically tourists visiting attractions such as the Stamp River Provincial Park, McLean's Mill and Chase and Warren Estate Winery.

The applicant has put a considerable amount of effort into designing a development plan that will first and foremost meet the engineering requirements for a food establishment and distillery operation but also provide an attractive site with the building having a farmhouse look with natural landscaping. Planning staff is of the opinion that the proposed development will be an improvement to the site and return a local commercial

establishment to an area that has been underserved since the previous operation at the site ceased a decade ago.

The property is located about 400 metres west of the Kackaamin Family Development Centre on Beaver Creek Road which is a family healing and addiction recovery centre. Through the neighbour notification process staff will refer this development application to the Kackaamin Board of Directors for their review. Consideration will be given to the fact that the temporary use permit will only allow for the craft distillery with on-site retail sales and tasting room while the existing C4 District zoning would allow for a restaurant or similar establishment which could include an application for a Food Primary or Liquor Primary License.

Describe the proposed development of the subject property.

A building (30' x 32') would hold a very small craft distilling operation and a very small coffee shop with a few gifts and convenience items. It would be designed with a farmhouse look—white shingles with black trim to fit in with the building next door and country ambiance. It would be nicely landscaped.

#### Reasons and comments in support of the application

The property in consideration is on Beaver Creek Road which includes visitor attractions such the Stamp Falls Provincial Park, and just off the road, McLean Mill and the Chase and Warren winery. The Stamp Falls Coffee Shop and Stamp Falls Distillery are meant to be a destination for visitors—including tourists, visitors from other local communities such as Qualicum Beach and Ucluelet, and people who live in the city who want a weekend outing that might include a visit to the Stamp River Provincial Park, McLean Mill or the winery. The property would be landscaped, ideally including trees and shrubs that had flowers in most months of the year.

A goal is to add to the rationale for people visiting the Port Alberni area to spend a little more time here rather than driving straight through to other destinations such as Tofino.

That being said, even though it is designed to be a very small distillery, much of the product would be sold offsite. The expectation is that there would be half a dozen visitors at a time on a good day.

The gift area of the coffee shop although small would include items of interest to tourists but would also focus on local crafts and it might be possible to showcase a local crafts person for a few hours on summer weekends. The Alberni area has a history of crafts and artisan production and is home to many people who create pottery, quilts, woodwork and knitting either part time or fulltime. It would also carry a few convenience items such as milk and bread for people camping at Stamp Falls and even local residents (although it is the type of community where someone who ran out of milk would be likely to borrow some from a neighbour).

The distillery would be used to demonstrate the farm to distilling process and ideally a little corn might be grown in a neighbouring field.

On behalf of my company, Teletech Communications Ltd., owner of the commercial property at 7960 Beaver Creek Road, Port Alberni, BC, I am requesting a temporary adaptation to the existing commercial zoning. The following provides information requested in the application for development.

Describe the proposed development of the subject property.

This adaptation would enable construction and operation of a building on the property (30' x 32') that would house a small coffee shop (seating for eight) with a few gifts and convenience items in one section and a small craft distilling operation on another section. The building would be designed with a farmhouse look—white shingles with black trim to fit in with the building next door and create country ambiance. It would be nicely landscaped.

Reasons and comments in support of the application.

That being said, even though the building is designed to house a small coffee and gift shop and a small distillery, the expectation is that there would be half a dozen visitors at a time on a busy summer day.










Figure 3: View towards Beaver Creek Road from access road on west side of lot.




Figure 4: View to east towards adjacent property from south side of lot.


AND WHEREAS an application has been made to rezone a property;

**Subject:** Proposed Management Approaches for Marbled Murrelet & Northern Goshawk

# **Recommendation:**

THAT the Board of Directors provide a letter to the Ministry of Forests, Lands and Natural Resource Operations regarding the proposed management approaches for the Marbled Murrelet (MAMU) & Northern Goshawk (NOGO) indicating concern with the current proposal which will exhaust all conservation efforts on Crown land without enforcement on private lands, and to request that a socioeconomic analysis be conducted of impact to crown land forest tenure holders.

### **Desired Outcome:**

An opportunity for the Board of Directors to provide meaningful input into the Ministry of Forests, Lands and Natural Resource Operations proposed management approaches for Marbled Murrelet & Northern Goshawk. These approaches seek to meet commitments in the 'Accord for the Protection of Species at Risk in Canada' and the 'Canada-British Columbia Agreement on Species at Risk'.

# **Background:**

The Province is currently engaging with stakeholders who may be affected by the proposed management approaches for Marbled Murrelet & Northern Goshawk. The province is requesting feedback from affected stakeholders by March 31, 2016.

The Marbled Murrelet are small seabirds that are a species at risk listed as 'Threatened' under the federal *Species at Risk Act* and are provincially 'Blue' listed. Their at-risk status is due mainly to the loss and fragmentation of their old-growth nesting habitat and due to threats in their marine habitats where they feed. Significant protection of MAMU habitat is in place through various types of conservation designations (e.g., Parks & Protected Areas, Land Act Reserves, Old Growth Management Areas, Wildlife Habitat Areas). It is estimated that an additional 210,000 hectares of MAMU habitat would have to be protected in order to achieve the federal minimum thresholds that would be applied to Crown lands only. Proposed actions in 2016 also include engaging with private land holders to encourage shared stewardship of Marbled Murrelet habitat on non-Crown land, particularly in the East Vancouver island

Conservation Region.

The Northern Goshawks are raven-sized raptors that live in mature and old-growth forests in coastal BC and are listed as 'Threatened' under the federal *Species at Risk Act* and are provincially 'Red' listed. Their at-risk status is due mainly to their small population size and the loss and fragmentation of their nesting and foraging habitat. The proposed BC management approach for breeding areas is to, by 2020, protect 95 new NOGO breeding areas around occupied nests, including 30 in the Vancouver Island Conservation area. The federal critical habitat for breeding areas is described as an approximately 200 hectare reserve. The science to support foraging habitat management requires further investigation. Managing for foraging habitat (in addition to breeding habitat) could have significant socio-economic implications. Proposed actions in 2016 also include engaging with private land holders to encourage shared stewardship of Northern Goshawks on non-Crown land, particularly in the Vancouver island Conservation Region.

A strong socio-economic analysis will help to assess the costs of these management plans and the benefits to be achieved from implementing these plans.

# **Policy or Legislation:**

Although the proposed management approaches for the Marbled Murrelet & Northern Goshawk are intended for Crown land, the Regional District could monitor the direction of the Province and consider employing the final management approaches on Alberni-Clayoquot Regional District properties where possible, and encourage these management approaches on private property within the Regional District.

### **Recommendation:**

That "Development Procedures and Fees Bylaw P1342, 2016" be read a first time.

#### **Desired Outcome:**

The proposed procedures and fees bylaw provides for a clear development application process, incorporates the fees structure and delegates development permits to staff that deal with protection of the natural environment and protection of development from hazardous conditions. This will enable a more efficient development permit process while meeting the requirements of the Electoral Area OCPs and *Local Government Act*.

#### **Summary:**

At the November 4, 2015 Electoral Area Directors Committee meeting, the Committee directed staff to prepare a procedures bylaw that would delegate the authority to issue certain development permits to staff. Bylaw P1342 delegates protection of the natural environment and protection of development from hazardous conditions to staff and sets out the procedures to appeal a staff decision to the Board. Form and character development permits for commercial, industrial and multi-family developments will still be reviewed by the area APC and approved by the Board.

When processing development permits that are delegated to staff, planning staff will first refer the development permit report to the area director, similar to what is the current practice for crown lease and miscellaneous referrals.

# Background:

See the attached October 26, 2015 staff memorandum to the Electoral Area Directors Committee.

# <u>Time Requirements – Staff & Elected Officials:</u>

If adopted, Bylaw P1342 will reduce the number of development permits that are reviewed by the local APC and approved by the Board. This will allow development permits to be issued in a timely manner.

#### Financial:

There are no financial implications.

# **Policy or Legislation:**

The Local Government Act states that the Board must approve development permits, by resolution, under Section 490 unless the local government delegates the power to issue development permits, by bylaw, under Section 229.

The bylaw will also increase the public notice requirements for development applications under Part 14 of the *Local Government Act* including public hearings related to zoning or OCP amendments, development variance permits, temporary use permits and phased development agreements. Public notice for the above noted development applications shall be mailed or otherwise delivered to owners and occupants of parcels located within 100 metres of the subject property. Currently, the ACRD Zoning Bylaw requires that notification is sent to all owners and occupants within 60.96 metres (200 feet) of the subject property under application.

# **Options Considered:**

The other option is to maintain the status quo and for the APC to review the development permit and for the Board to approve.

**Subject:** Development Variance Permit Procedures

#### Recommendation:

That the Electoral Areas Committee direct staff to prepare a Development Approval Procedures Bylaw that includes a section that delegates the power to issue Development Permits, under sections 919.1 (1) (a) protection of the natural environment and (b) protection of development from hazardous conditions only, to the CAO.

### **Desired Outcome:**

To provide an efficient review time while meeting the development permit guidelines set out in the ACRD Official Community Plans.

# Background:

All of the ACRD Electoral Area Official Community Plans now include new development permit areas for both; protection of the natural environment under Section 919.1 (1) (a) of the *Local Government Act* and protection of the development from hazardous conditions under Section 919.1 (1) (b) of the *Local Government Act*. As a result the ACRD is seeing a significant increase in applications for these types of development permits.

There has been discussion both at the Regional Board level and amongst the six Advisory Planning Commissions about the process for reviewing and approving these development permits. To apply for these two types of development permits a report, with recommendations, is required from a professional biologist or a geotechnical engineer. The professional biologist or a geotechnical engineer recommendations then form the development permit requirements prepared by ACRD planning staff. If the development permit application meets the ACRD's development permit guidelines and complies with the professional's recommendations, the development permit must be issued.

As part of the new zoning bylaw review, planning staff will prepare a draft Development Approval Procedures bylaw. Currently, development application requirements are included within the zoning bylaw. As part of a development approval procedures bylaw, the Board may delegate some or all development permit approvals to staff. This must be done by bylaw.

Staff recommends only development permits for protection of the natural environment and protection of development from hazardous conditions be delegated to the CAO. Other development permits, which currently include form and character development permits for commercial and industrial developments, would be reviewed by the APC and approved by the Board.

# **Policy or Legislation:**

The Local Government Act states that the Board must approve development permits under Section 920 unless the local government delegates the power to issue development permits, by bylaw under sections 895 and 920 (12) of the *Local Government Act*. The Act contains a provision for an applicant to have the Board review a development permit that was denied by staff.

# **Options Considered:**

The other option is to maintain the status quo and for the APC to review the development permit and for the Board to approve.

A bylaw to establish development procedures and fees within the Regional District of Alberni-Clayoquot in accordance with Part 14 of the *Local Government Act* 

**WHEREAS** the Board of Directors of the Regional District of Alberni-Clayoquot has adopted official community plans and a zoning bylaw;

**AND WHEREAS** the Board has designated areas within which development permits may be required;

**AND WHEREAS** the Board may, pursuant to Section 229 of the *Local Government Act*, delegate its powers, duties and functions to an officer or employee of the regional district;

**AND WHEREAS** the Board may from time to time issue temporary commercial use permits or temporary industrial use permits;

**AND WHEREAS** the Board must, pursuant to Section 460 of the *Local Government Act*, by bylaw, establish procedures to amend a plan or bylaw or to issue a permit;

**AND WHEREAS** the Board may, pursuant to Section 462 of the *Local Government Act*, by bylaw, impose fees for applications and inspections;

**AND WHEREAS** the Board may, pursuant to Section 466 of the *Local Government Act*, by bylaw, impose requirements for the posting of notification signs on properties that are subject to a proposed development;

**AND WHEREAS** the Board may, pursuant to Section 502 of the *Local Government Act*, require that the applicant for a permit under Part 14 of the Local Government Act provide security in an amount stated in the permit in a form satisfactory to the Board;

**NOW THEREFORE** the Board of Directors of the Regional District of Alberni-Clayoquot, in open meeting assembled, hereby enacts as follows:

#### 1. Citation

This Bylaw may be cited for all purposes as "Development Procedures and Fees Bylaw P1342, 2016".

#### 2. Schedules

The following Schedules are attached to, and form part of, this Bylaw:

- a) Schedule "A" Application for Development
- b) Schedule "B" Application Fees

### 3. Purpose and Scope

- a) The purpose of this Bylaw is to establish procedures for applications and referrals including the establishing of fees, forms, procedures and delegated authorities.
- b) This Bylaw shall be applicable to all lands and surface of the water within the Alberni-Clayoquot Regional District (ACRD) that are subject to any permit or application procedures as outlined in this Bylaw.
- c) This Bylaw applies to the following applications, permits and referrals to the ACRD:
  - i. bylaw amendments to Official Community Plans (OCPs) and Zoning Bylaw,
  - ii. the issuance of development permits and development variance permits,
  - iii. the issuance of temporary commercial use permits and temporary industrial use permits,
  - iv. subdivision application referrals,
  - v. Agricultural Land Reserve applications,
  - vi. discharge or consent to amendment of a Restrictive Covenant to which the ACRD is a signatory or named party,
  - vii. file review in response to a letter requesting a review of many aspects of a parcel's status such as present or historical zoning, building permits, bylaw enforcement and other permits, and
  - viii. requests to extend the term limit of a development permit or development variance permit.
- d) Schedule "A" and "B" attached hereto and forming part of this Bylaw are hereby adopted as the planning procedures and fees for the Alberni-Clayoquot Regional District.

# 4. Applications

- a) Applications listed in Section 3 shall be made by the owner of the land involved or by a person authorized by the owner.
- b) Applications for amendments or permits shall be made to the ACRD, on the applicable form, attached hereto as Schedule "A" of this Bylaw.
- c) Applications shall contain all the information required by the application form.
- d) Applications for subdivision shall be made through the Ministry of Transportation and Infrastructure (MoTI). A referral fee request shall be sent to the applicant by the ACRD upon receipt of the application referral from MoTI. Receipt of the requested fee is required prior to the ACRD providing a response to MoTI.
- e) If there is a change of ownership of property or land that is the subject of application or referral, the Manager of Planning and Development may require an updated State of Title Certificate and written authorization to proceed with the application from the new owner prior to proceeding further with an application or referral.
- f) Where an applicant under this Bylaw has not pursued the application for a period of twelve months, after being asked by ACRD staff to provide further information or to follow a procedure outlined in this Bylaw, the application is deemed to be inactive, and the file will be closed. Any refund pursuant to Section 6) below will be issued at the time of file closure.
- g) Approximately three months before file closure or nine months into an inactive period, a warning letter will be sent to the applicant advising them that their file is about to become inactive.
- h) An application or substantially similar application may not be submitted in respect of the same development less than one year from the date of refusal of a previous application, unless the Board has agreed to such a reconsideration.
- i) The Board may, on receipt of an application to amend a plan or bylaw, resolve to proceed with an amendment bylaw or resolve not to proceed with the application. The Board may, on receipt of a permit application, resolve to proceed with or resolve not to proceed with the permit.
- j) The Board may initiate an amendment to a plan or bylaw without first receiving an application to amend.

### 5. Delegation

The Board hereby delegates to the CAO its authority for the issuance of development permits for the protection of the natural environment and the protection of development from hazardous conditions.

#### 6. Comprehensive Development Area Applications

- a) Applications to develop CDAs shall be planned in collaboration with the ACRD, taking into account any unique features of the land, the protection of sensitive ecosystems, the benefits of utilizing planning tools such as density averaging and phased development, and the feasibility of a mix of land uses.
- b) Where land has been designated or is subject to a request to be designated as a Comprehensive Development Area (CDA) in an OCP, that land shall also be designated as a Development Approval Information Area (DAIA) in the OCP.
- Applications shall be accompanied by all information specified by DAIA Bylaw No.
   P1324 shall be provided to the Manager of Planning and Development.

#### 7. Permit Term Limit Extension

Development permits and development variance permits issued by the ACRD contain term limits, otherwise known as expiration dates. The term limit forms part of the permit, and requests to extend the term limit are subject to approval by the ACRD Board or delegated authority.

Requests to amend the term limit of a permit may be considered for a maximum three-year extension, beyond which a new application for development permit or development variance permit is required. A written rationale for the extension must be submitted, accompanied by an application for development permit or development variance permit form, a current State of Title Certificate, application fee and updated project plans or drawings if applicable.

Where a first-time, one-year extension request has been made, the ACRD Board delegates approval authority to the Manager of Planning and Development. All other requests will be the subject of a Planning and Development Department report for consideration by the ACRD Board. Amended permits require registration with the Land Titles Office.

#### 8. Fees

- a) At the time of an application listed in Section 3, the applicant shall pay to the ACRD an application fee in the amount prescribed in Schedule "B" of this Bylaw.
- b) A separate fee is payable in respect of each separate parcel of land that is the subject of an application or a referral, but only a single fee is payable in respect of an application involving only contiguous parcels of land.
- c) In the case of permit renewals, a fee of half (50%) of the applicable fee stipulated in Schedule "B" must be paid.

#### 9. Fee Refund

- a) Where an application is withdrawn, in writing, by the applicant or has lapsed prior to referral of the application to other agencies or issuance of public notice or preparation of a staff report, the applicant shall be refunded 50% of the fees.
- b) When an application or referral has been processed in part and has lapsed due to inactivity or is incomplete and thus cannot be formally assessed, no refund shall be made.

# 10. Staff Duties, Reports and Processing

- a) Written reports prepared by staff of the Planning and Development Department shall be submitted to the appropriate Advisory Planning Commission (APC) and Electoral Area Director or more than one APC, as specified in an Official Community Plan, for applications for OCP amendments, zoning amendments and for development variance permits.
- b) In the case of development permits and Agricultural Land Reserve applications, these will not be sent to an APC unless the Director of the affected area specifically requests it.

# 11. Notification and Public Hearing

- a) The public notice requirements for development applications are prescribed in Part 14 of the *Local Government Act* and shall be issued in the following circumstances:
  - public hearing pursuant to Section 466 for an OCP or Zoning Bylaw amendment,
  - ii. issuance of a development variance permit,
  - iii. issuance of a temporary use permit, and
  - iv. phased development agreement.

- b) Public notice in any case noted in subsection a) above, other than development permit applications that do not incorporate a variance and Board of Variance applications, when required to be mailed, shall be mailed or otherwise delivered to the owners and occupants of parcels located within 100 metres of the subject property.
- c) The applicant may be required by the ACRD to erect or cause to be erected a sign on the subject property.
- d) Following a public hearing, the Board shall proceed in accordance with Section 470 of the *Local Government Act*.

#### 12. Permit – Issuance or Refusal

- a) The Board may, in the case of an application for a development variance permit or temporary commercial or industrial use permit:
  - i. authorize the issuance of the permit, or
  - ii. authorize the issuance of the proposed permit as amended by the Board in its resolution, or
  - iii. table the permit, or
  - iv. refuse to authorize the issuance of the permit.
- b) Where an application for a permit as noted in a) above is approved and a permit is issued, the permit will be registered on title to the subject property.
- c) Where an application has been refused by the ACRD Board of Directors or the CAO, the Manager of Planning and Development or a nominated designate shall notify the applicant in writing within 30 days immediately following the date of refusal.

### 13. Appeal

- a) Where an application has been refused by the CAO, the applicant shall have the right to appeal the delegated decision to the ACRD Board of Directors.
- b) An applicant who wishes to appeal the decision of the CAO shall submit an appeal request in writing to the Manager of Planning and Development within 60 days of the date of the decision.
- c) Where an appeal request is received, the procedures set out in Section 8 of this Bylaw shall be followed.

# 14. Severability

If any word, section, subsection, sentence, phrase or schedule of this Bylaw is for any reason held to be invalid by the decision of any court or competent jurisdiction, the invalid portion shall be severed and the portion that is invalid shall not affect the validity of the remainder of this Bylaw.

# 15. Repealed

The Regional District of Alberni-Clayoquot Bylaw to Set Fees and Charges for Development Applications and Related Services Bylaw No. F1069 is hereby repealed.

#### Re: 2016 NI 9-1-1 adopted budget

The North Island 9-1-1 Corporation 2016 recommended budget was adopted at the March 4, 2016 meeting of the board.

The board has approved an increase to the requisition for 2016. The requisition has been increased by 2.4% to \$2,269,760. The 2015 assessed property values have increased overall by 1.9% compared to 2014 values. With the requisition for 2016 increasing over the 2015 amount and the overall increase in property assessments in 2015, the tax rate levy per \$1,000 has increased to \$.066 from the 2015 rate of \$.065.

The table below provides the 2016 contribution amounts for each of the participating regional districts.

#### 2. Air Quality and Health

Air Quality and Health Paul Hasselback gave a presentation on key components of air

quality and health and discussed statistics around the fact that there are an excess of deaths following significant air quality

events.

	Regardless of how good air quality gets every improvement in air quality will lead to better health outcomes. There is no 'safe' level of air pollution.
Factors involved in improving air quality	Air Quality Monitoring and Forecasting Health communication and Research Policy
Air Quality and Health facts	It is estimated that, in BC, 385 acute premature deaths and about 1000 hospital admissions annually are linked to poor air quality.
	More and more research is coming out about the connection between air quality and virtually all diseases.

#### 3. Tire Derived Fuel (Catalyst Presentation)

What is Tire Derived Fuel (TDF)?	Tire Derived Fuel is a manufactured product that recycles old tires
	for use as fuel. All metal is removed from the tires and the tires are

chipped into 1.5 inch pieces.

Why is it used over straight hog? A small amount of TDF is added to the power boiler to enable

Catalyst to burn lower quality hog instead of burning oil or natural gas. This is primarily needed in the wetter winter months. The addition of the TDF increases the heat in the boiler and results in a

more efficient burn and has been shown to decrease emissions.

How much TDF is used? Averages out to about 2% over the 6 winter months. Air Emissions

Permit allows for up to 5%.

What is the impact of using TDF Burning TDF has been seen to benefit the mill and environment in from an environmental terms of lowering emissions from the Power Boiler. PM stack sampling results show a negligible or beneficial impact. perspective?

Given the sulfur content in tires SO2 emissions as a result of TDF are being examined through ambient air quality measurements (a 3-year program) and all levels recorded to date have been low. Zinc increased when using TDF. This is extracted and goes to the

landfill.

Levels of other metals were tested for and there was found to be negligible difference before and after TDF given the concentrations naturally found in trees.

TDF decreased chlorinated dioxins and furans from the boiler. It was found that this was a result of the sulfur that produces SO2. Of course some elements can not be tested for.

The emissions trend over the past 20 years has been steadily down ward.

Why doesn't Crofton use TDF when it's been found to be	Different technology used at the mill in Crofton.
beneficial here?	In fact, Crofton has a higher emissions rate per unit than here.

## 4. Wood Stove Exchange Program

Program Launch At	2016 Woodstove Exchange Program to launched on February 1 <sup>st</sup> , 2016.
Current Status	At this time 9 out of 31 vouchers have been claimed.
Possible May event	It was discussed that an event in May might be good to tie in with the one year remaining on the city woodstove sunset clause (May 2017) and get people stacking wood in advance for next winter. This could be combined with the burn it smart workshop for this year.
National Media	There has been significant media coverage about residential woodsmoke in recent weeks. The local paper, Vancouver Sun, and the Globe and Mail and ran articles.

## 5. Backyard Burning

Progress Update	Backyard burning ban effective April 2016. City will be working on bylaw revision to include this. AQC to support them in this and see where alternatives get developed that can be promoted at the same time.
	Aiming for May to discuss possible backyard burn guidelines with the ACRD. Turns out that guidelines were already drafted previously so they are on file and we can work from those.
	Goal is to work on all of this and lead up to a big public education push in the fall to show people alternatives to burning etc.
	With regards to burning, an emissions inventory done in Cowichan found that 70% of PM2.5 emissions can be attributed to woodsmoke (residential, backyard burning, land clearing, slash).

	If land clearing burning, earlier light up the better because of the nocturnal inversions. Best to burn between 11am and 3pm.
6. CanTimber Update	
Particulate Monitoring	A partisol PM2.5 sampler has been set up at Second Avenue and Bruce Street as part of their operational certificate from PAPA.
Current Status	The test and start up phase is ongoing. At this point expect they will be operational in 2 months time.
Air Emissions	Reports of smoke have been reported by staff at APD and from people in the residential area near Cantimber. The start up phase is predicted to have more emissions than regular operations so this should ease up as operations fully commence. Wood is being used for start up. Would probably have been better to use natural gas for start up to reduce localized emissions.
	If people have concerns they should bring them to the Port Alberni Port Authority.
