#### Summary:

The Regional Hospital District paid for 40% of the West Coast General Hospital (WCGH) construction using long term debt secured through the Municipal Finance Assocation (MFA). The balance of the debt outstanding is estimated to be approximately \$4.9 million at the end of 2016.

The tax requisition has been falling as debt continues to expire for the WCGH and the existing debt is reissued at lower interest rates. In fact, the tax rate could drop as much as 28.6% in 2017 from the previous year based on decreased debt costs and no additional projects being requested by Island Health (VIHA). Although a tax rate decrease is always appealing, the tax rate would see a similar increase in later years when a new project is presented such as a new facility in Tofino. In an effort to avoid a negative spike in the requisition staff has investigated options for leveling out the requisition.

One of the recommendations of staff is to take advantage of the opportunity to pay out MFA Issue #78 when it is refinanced in the fall of 2017. The current balance is \$178,784.93. The other recommendation is to create a reserve fund for future projects. Based on the estimated actuals for 2016, a contribution of \$200,000 could be budgeted without an increase to the requisition amount from the prior year. The creation of a reserve fund is permitted under the Hospital District Act and is a practice of several Regional Hospital Districts in the Province.

In 2014 the ACRHD requisitioned \$1 million dollars in anticipation of a major renovation to the

Emergency Room at the WCGH. VIHA originally estimated the project to cost \$4 million but the project has been delayed due to other more urgent priorities within VIHA. In advance of starting the project in either 2017 or 2018, VIHA is reviewing the scope. Based on discussions with Chris Sullivan, Island Health Capital Planning Director, a revised cost estimate is underway and will hopefully be provided in advance of the 2017 Annual Budget being adopted. It is not anticipated that further funds will be requested from the ACRHD but instead the project may actually decrease by as much as 20%.

As in prior years, the provisional budget includes an equipment and minor capital grant of \$550,000 for VIHA to purchase equipment and complete projects for the hospitals in the Region. VIHA will provide a letter in February 2017 explaining their plan in the Region.

### Time Requirements - Staff & Elected Officials:

There will be some time required of staff and elected officials to review the specific funding requests as they come in from Island Health.

#### Financial:

The requisition will be the same as the prior year. The residential tax rate will remain at \$0.289 per \$1,000 of assessed value.

### **Policy or Legislation:**

The Alberni-Clayoquot Regional Hospital District is required by Section 23 of the Hospital District Act to adopt a provisional budget by December 31<sup>st</sup> for the following year. Section 20(4) permits the Hospital District to carry forward funds from one year to the next as recommended by staff in the creation of the reserve fund.
