Subject: 2016 Annual Budget

Recommendation:

THAT the Alberni Clayoquot Regional Hospital District Board of Directors give second and third reading as well as adoption to Bylaw 120, cited as "Alberni-Clayoquot Regional Hospital District 2016 Annual Budget No. 120".

Summary:

The Regional Hospital District paid for 40% of the West Coast General Hospital construction using long term debt secured through the Municipal Finance Authority (MFA). The balance of the debt outstanding was approximately \$5.8 million at the end of 2015.

In addition to funding the long term borrowing for the West Coast General Hospital the Hospital District also provides Island Health funding to complete other capital projects and purchase equipment for our region. This includes the \$550,000 annual commitment for small equipment grant and small capital expenditures within the ACRHD.

Discussions with Chris Sullivan, Island Health Capital Planning Director, determined that an additional capital equipment purchases in 2016/17 are available. Great news for the West Coast General Hospital to see some investment in equipment for 2016/17, although the planned debt pay down would need to be used in this for our 40% contribution to equipment. Staff recommended at 1st reading to move the budgeted \$300,000 of additional debenture debt principal funds to equipment funding in 2016/17. Also there was unallocated funds from the prior 4 years that make up part of the annual equipment and minor capital grant of \$550,000, these funds can be repurposed towards the equipment rather than increased tax requisition in 2016 as listed in the letter from Island Health.

<u>Time Requirements – Staff & Elected Officials:</u>

There will be some time required of staff and elected officials to review the specific funding requests as they come in from the Vancouver Island Health Authority.

Financial:

The requisition will be \$6,032 higher (0.36% increase over 2015) than that of the prior years. The

residential tax rate is \$0.289 and the change to the regarding Maa-nulth members being excluded from participating in debt that was initiated prior to their membership of the board has been calculated (see attached tax requisition breakdown).

Policy or Legislation:

The Alberni-Clayoquot Regional Hospital District is required by Section 23 of the Hospital District Act to adopt an annual budget by March 31 of each year.

Options:

If any amendments are required they should be made during second reading.
