Subject: Cherry Creek Waterworks District – Gas Tax funding request

Recommendation:

That the Electoral Area Directors Committee recommend that the Alberni-Clayoquot Regional District Board of Directors deny the Cherry Creek Waterworks District request for \$625,000 of Community Works Funding.

Desired Outcome:

To utilize the Community Works Funding to address the infrastructure demands within the services of the ACRD.

Summary:

The Cherry Creek Waterworks District (CCWW) was a delegation at the March 8, 2017 Board of Directors meeting and provided a letter requesting \$625,000 of Community Works Funding to replace some aging water main within their system. The delegation was received and referred to the Electoral Area Directors Committee for further discussion.

While there may be political interest to allocate funds across each electoral area based on population, this is not a condition or requirement of the program. It is the position of staff that priority be given to critical infrastructure needs of the ACRD services. This may not result in a population-based allocation across the electoral areas, but it does reflect the critical needs of the services that the Board established. Each electoral area participates in various ACRD services that have projects that meet the eligible criteria. The funds can also support projects outside electoral areas that benefit municipalities and first nations with no ties to geography. The Water Systems are a priority in consideration of:

- The Board defining water systems as one of its priorities for Community Works Funding projects;
- The systems are 100% the responsibility of the ACRD;
- The water system needs exceed the ability of residents to pay. Reports and studies have identified requirements in excess of \$9 million for these water systems, with regulation and standards increasing, the systems aging and the impact of inflation, these costs are bound to increase;
- Alberni Valley regional water capital infrastructure costs, which may include filtration, will require a large capital contribution from the Beaver Creek Water system as their share of the project.
- Residents connected to these water systems will be paying for other improvements and will be realizing
 increased costs for taxes and tolls. Many of these communities are struggling economically;
- Water is essential; the integrity of water quality will be compromised if infrastructure needs are not addressed.

Cherry Creek Waterworks District has requested the funding on the need to renew AC water mains. It should be noted that the ACRD water systems have an abundance of asbestos concrete (AC) water mains and materials that predate the production of AC pipe.

There are needs within the ACRD water system asset that must be considered and a comparison of the percentage of AC in Beaver Creek is higher than CCWD with 60% of the pipe in the ground AC. The Long Beach Airport has steel watermains installed in the 1940's that are at the end of their life, with virtually no capital available to complete these replacements. Bamfield will be faced with increasing operational cost and still require renewal for the water system and their system is aging. Millstream will be completing the infrastructure assessment to identify all required capital projects within 2017.

Background:

The ACRD has previously provided CCWW \$385,000 of Community Works Funding for water system upgrades, this was to complete key water main upgrades.

<u>Time Requirements – Staff & Elected Officials:</u>

Staff and elected officials time for concurrence with the staff recommendation would be minimal.

Financial:

Based on the 2017-2021 Financial Plan there will be an estimated \$1 million of Community Works Funds available for eligible projects. Although the Renewed Gas Tax agreement extends to 2024 the funding commitment from the Federal Government beyond 2018/19 is unknown at this time.

It should be noted that the \$600,000 allocated to the Bamfield Water System in 2016 was specifically for the Water Treatment Plant upgrades but the ACRD has since received a grant from the Clean Water & Wastewater Fund for this project. Many critical infrastructure demands are still facing the Bamfield Water System and will require significant capital funding to complete. Staff will be presenting an update of previously committed Community Works Fund projects as well as recommendations for future projects in advance of the 2018-2022 Financial Plan discussions.

Policy or Legislation:

The eligible project categories of the Community Works Fund include:

2. Wastewater
4. Solid waste
6. Community energy systems
8. Brownfield redevelopment
10. Sport infrastructure
12. Recreational infrastructure
14. Cultural infrastructure
16. Tourism infrastructure
18. Capacity building

Options Considered:

Staff recommends that if the Electoral Area Directors are contemplating allocating a substantial amount of money to CCWD that there be greater accountability and cooperation on critical decisions moving forward. A cooperation agreement between the two organizations would be beneficial including that an agreed amount of Community Works Funding for Cherry Creek water system improvements be conditional on the following:

- The priorities for these funds would be agreed to after a comprehensive review of all capital projects and longterm cost implications of those projects – water mains, dam and water treatment needs and available alternative funds (CCWW reserves, grants, etc.).
- The ACRD must provide proof that the organization is progressing on the Asset Management process in order to continue to receive Community Works Funding. If the ACRD provides funding to other organizations, moving forward the need to ensure they meet the same criteria must be in place to maintain compliance fund the funding agreement.

- An assessment is made by a qualified third party on the options for water treatment for Cherry Creek as was completed for the Beaver Creek Water System.
- The two organizations negotiate an agreement for water system maintenance and level of service expectations.
- Governance be considered and the merits of a regional option considered in the context of alternative grant funding for the water treatment option selected.

Subject: Consideration of an Animal Control Service for Livestock At Large

Recommendation:

THAT the Board of Directors refer the consideration of an animal control service for livestock at large to the Electoral Area Directors Committee for discussion.

Desired Outcome:

To initiate Board discussion on the implementation of an animal control service in the Electoral Areas to regulate livestock at large.

Summary:

At the January 25, 2017 regular meeting, the Board directed staff to investigate a bylaw for impounding and licensing of animals in rural areas in response to concerns raised by residents. Staff were asked to investigate a similar service provided by the Comox Valley Regional District (CVRD).

Through establishing a service area and adopting a regulatory bylaw, the Regional District has the ability to control animals at large. The CVRD animal control service is investigated in detail later on in this report. The cost of the Comox Valley Animal Control service is approximately \$140,000 in the 2017 proposed budget. This service includes the licensing and control of dogs as well as agricultural animals and the CVRD has a ticketing bylaw in place which allows them to issue a \$100 fine for allowing an animal to run at large.

If the Board were to establish a service to control livestock at large, coming up with funding for an effective enforcement system would be critical. There would be personnel costs for the Bylaw Enforcement Officer to attend calls and investigate complaints, contractor costs for a trained professional to impound the animals, kenneling/pound costs and potential costs for pursuing legal action if required.

Staff are recommending that a preliminary estimate for an effective livestock control service would require, at minimum, +/- \$50,000 per year which would amount to one third of the cost of the CVRD service. In order for enforcement to be effective, staff are also recommending that a ticketing bylaw be

implemented to allow fines to be issued for non-compliance. Contractors would need to be retained to retrieve or impound animals at large and to provide kenneling.

Background:

The CVRD established a service in 1981 to provide animal control within a portion of their Regional District. CVRD Electoral Areas Animal Control Bylaw No. 100, 2010 regulates animal control within Electoral Area B (Lazo North), Area C (Puntledge-Black Creek) and the Vancouver Island portion of Electoral Area A (Baynes Sound excluding Denman and Hornby Islands). The bylaw regulates the control of both domestic and agricultural animals and includes regulations on dog licensing and a prohibition on any dog or animal allowed to run at large within the service area.

The CVRD has a Municipal Ticket Information system enabling officers to issue tickets for infractions or proceed to court. The ticketing bylaw includes tickets for "permitting/allowing animal to run at large" with the fine amount being \$100. On average, the animal control officers issue eight to ten tickets a year for animals at large and have issued tickets for incidents of goats, sheep and horses at large. Other than ticketing, they have used long form information and obtained consent orders through Provincial Court as well as Supreme Court injunctions.

For repeat offenders/infractions, often they will have them enter into an agreement/contract to prevent their livestock from running at large and waive or reduce pending fine amounts to obtain long term compliance. They have had a high success rate with obtaining compliance and working with the owners and complainants. The challenges with enforcing animal control, specific to livestock, is often the cost of impounding or removing the animals if the owner cannot be readily located. Often these areas are remote and officers are not able to attend as quickly as they could if the area was closer to town, which often results in an investigation after the fact. The CVRD has a contract with the Corps of Commissionaires to provide animal control service (includes dogs) and bylaw staff will assist with issuing tickets or court proceedings as required.

Funding for the service is provided through a tax calculated at \$0.0248 per \$1,000 of the assessed value of a home along with additional funds collected through the sale of dog licenses. The 2017 provisional budget for the service is provided below; please note that the budget includes the animal control contract for \$48,000 separate from the kennel contract with their local SPCA.

<u>Time Requirements – Staff & Elected Officials:</u>

Regulatory bylaws are enforced on a complaint basis and while a limited number of complaints per year would be anticipated, it would be expected that significant staff time would be required once a complaint is received. Staff time would be required to attend the site, investigate, dialogue with the complainant and animal owner, prepare paperwork for ticketing, facilitate support from animal control contractors and potentially prepare documents to proceed with legal action.

Financial:

There would be an annual cost to establishing and enforcing an animal control service for livestock at large. For discussion purposes, staff have put forward an annual budget of \$50,000 as a minimum to establish an effective service. Accounting staff have prepared a 2017 requisition estimate for a livestock roaming service for the four Electoral Areas in the Alberni Valley (Beaufort, Sproat Lake, Beaver Creek and Cherry Creek). The requisition estimate is attached to this report as Appendix 'A'. This requisition is based on land and improvements. If the board wishes to look at establishing this service, other options such as a parcel tax can be investigated.

Policy or Legislation:

The *Livestock Act* designates Livestock Districts (areas where livestock may be at large) and Pound Districts (areas where livestock at large are subject to capture). A designated pound district would require action by a local government to designate a pound and a manager with powers to impound livestock at large. The ACRD has not been designated either a Livestock District or a Pound District under the *Livestock Act*, effectively meaning that the provisions of the Act do not apply to our area.

The *Range Act* allows livestock to be at large on Crown land where specific conditions are set out in a grazing tenure.

Previous correspondence from the Ministry of Agriculture District Agrologist for our area confirmed that there is no provincial legislation applicable to our area that would require the control of livestock. If the Regional District wishes to regulate livestock at large, a service will need to be established and a regulatory bylaw adopted.

Options Considered:

- 1) Establish a service to control livestock at large in the four Electoral Areas in the Alberni Valley.
- 2) Continue to not regulate livestock at large.
