### Information - General Local Election 2018

The following information is provided to eligible voters of the **Huu-ay-aht First Nation** regarding voting in the upcoming local government election on **October 20, 2018**.

Qualified electors of the **Huu-ay-aht First Nation** can vote for the following:

#### **School District Trustee - Electoral Area #2 (Alberni Valley & Bamfield)**

#### **Am I Eligible to Vote?**

To be eligible to vote as a resident or non-resident elector, you will be required to make a declaration that you meet the following requirements:

- 18 years of age or older on general voting day
- Canadian citizen
- resident of BC for at least 6 months immediately preceding the day of registration
- resident of OR registered owner of real property in trustee electoral area #2 for at least 30 days immediately preceding the day of registration, and
- not disqualified under the *Local Government Act* or any other enactment from voting in an election or otherwise disqualified by law.

#### **Who is running for office and where do I vote?**

The attached notice of Election by Voting provides all the details regarding the upcoming election including; candidates running for School District Trustee Electoral Area #2, voting dates, locations, elector eligibility, elector registration and identification required to vote.

### ELECTOR REGISTRATION

There is no need to pre-register to vote as the registration of all electors for this election will take place at the time of voting. You will be required to make a declaration that you meet the following requirements:

- 18 years of age or older on general voting day
- Canadian citizen
- resident of BC for at least 6 months immediately preceding the day of registration
- resident of OR registered owner of real property in the regional district electoral area or trustee electoral area for at least 30 days immediately preceding the day of registration, and
- not disqualified under the *Local Government Act* or any other enactment from voting in an election or otherwise disqualified by law.

**Resident electors** must produce **2 pieces of identification** (at least one with a signature). Picture identification is not necessary. The identification must prove both residency and identity.

**Non-resident property electors** must produce **2 pieces of identification** (at least one with a signature) to prove identity, **proof** that they are entitled to register in relation to the property, and, if there is more than one owner of the property, **written consent** from the majority of the property owners. #### MAIL BALLOT VOTING

Qualified electors may vote by mail if they:

- have a physical disability, illness or injury that affects their ability to vote at another voting opportunity, OR
- expect to be absent from the Alberni-Clayoquot Regional District on general voting day and at the times of all advance voting opportunities.
- Reside in Electoral Areas: “A” (Bamfield), “B” (Beaufort), “C” (Long Beach), “D” (Sproat Lake), “E” (Beaver Creek), “F” (Cherry Creek) or Maa-nulth First Nations: Huu-ay-aht First Nation, Toquaht Nation, Uchucklesaht Tribe Government or Yuułu?if?atḥ Government that are remote from the voting places at which they are entitled to vote where their only access to their residence is by boat or aircraft, or their travel time by road from their residence to the nearest voting place at which the person is entitled to vote is greater than thirty (30) minutes.

#### REQUESTING A MAIL BALLOT PACKAGE:

Before **4 pm** on **October 19, 2018** you must submit an **Application to Vote by Mail** which can be downloaded off the ACRD website [www.acrd.bc.ca](http://www.acrd.bc.ca) to the Alberni-Clayoquot Regional District Office either by mail (3008 Fifth Avenue, Port Alberni, BC V9Y 2E3), fax (250-723-1327) or email [wthomson@acrd.bc.ca](mailto:wthomson@acrd.bc.ca).

The Alberni-Clayoquot Regional District will send out mail ballot packages commencing on or about October 1, 2018. If your application is received after October 12<sup>th</sup> and time does not permit mailing, you should arrange to pick up a package from the ACRD Office, 3008 Fifth Avenue, Port Alberni, BC. To be counted, your mail ballot must be received by the Chief Election Officer no later than 8 pm on Saturday, October 20, 2018.
