Cherry Creek Community Recreation Commission Grant Service Establishing Bylaw

Bylaw No. E1069

A bylaw to establish a service within electoral area “F” (Cherry Creek) to provide an annual grant to the Cherry Creek Community Recreation Commission

WHEREAS the Board of the Regional District of Alberni-Clayoquot (the Regional District) may, by bylaw, establish and operate any service that the Regional District Board considers necessary or desirable for all or part of the Regional District;

AND WHEREAS under the *Local Government Act*, the Regional District Board may establish and operate a service for the purpose of providing financial assistance in relation to community facilities within one or more participating area;

AND WHEREAS the Regional District Board wishes to establish a service for the purpose of providing an annual grant to the Cherry Creek Community Recreations Commission to support their community hall located within Electoral Area “F” (Cherry Creek);

AND WHEREAS the Regional District Board has obtained the required approval of the electors and the approval of the Inspector of Municipalities, as required by the *Local Government Act*, for the establishment of this service;

NOW THEREFORE the Board of the Regional District of Alberni-Clayoquot, in open meeting assembled, enacts as follows:

1. CITATION

This bylaw may be cited as the “Cherry Creek Community Recreation Commission Grant Service Establishing Bylaw No. E1069, 2026”

2. SERVICE

The service being established under the authority of this bylaw is for the creation of a service to provide the Cherry Creek Community Recreation Commission with an annual grant supporting the operation and maintenance of their community hall.

The boundaries of the service area are specified on Schedule “A”, attached to and forming part of this bylaw.

The participants of the service established under this bylaw are all of Electoral Area “F” (Cherry Creek).

- a. Property values taxes imposed in accordance with Division 3 of Part 11 of the *Local Government Act*
- b. Revenues raised by other means authorized under the *Local Government Act* or another act, and,
- c. Revenues received by way of agreement, enterprise, gift, grant or otherwise.

In accordance with the *Local Government Act*, the maximum amount that may be requisitioned annually of this service shall not exceed \$25,000 or \$ 0.0408 per \$1,000 of net taxable value of land and improvements, whichever is greater.

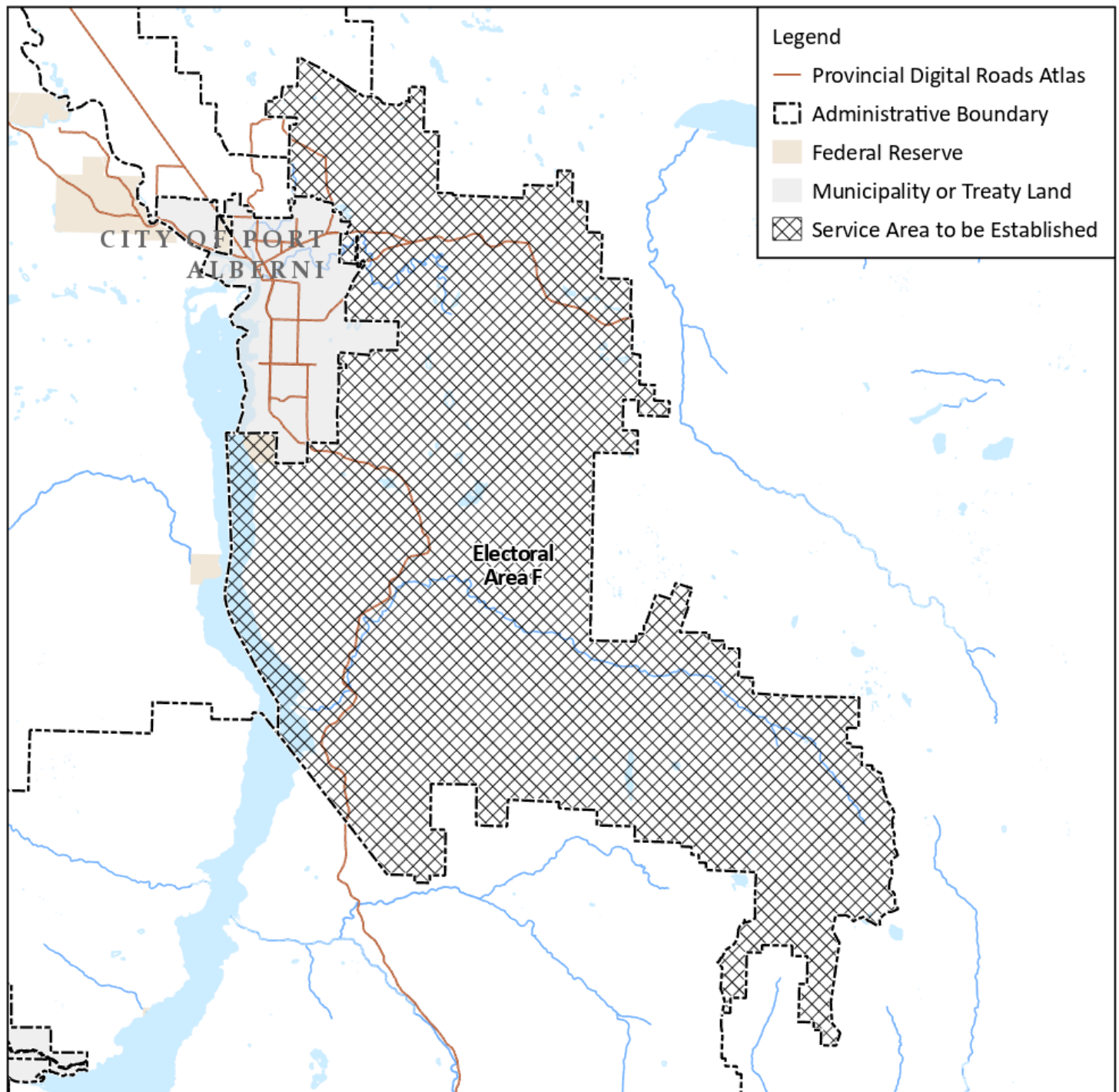
