3. Section 2 of By-law No. 329 is repealed and the following substituted:


(2) The Parcel Tax shall be levied in each year on each of the aforesaid parcels of land and the amount therefore shall be \$237.39 on each parcel.

4. This By-law shall come into force and take effect on and after the date of the final passing thereof.



The Board of the Regional District of Alberni-Clayoquot in open meeting assembled, enacts as follows:


1. This By-law may be cited for all purposes as the "Bamfield Water System Parcel Tax By-law Amendment By-law No. 382, 1982".

BY-LAW NO. 329

A BY-LAW OF THE REGIONAL DISTRICT OF ALBERNI-CLAYOQUOT TO IMPOSE A
PARCEL TAX ON OWNERS OF LAND IN THE BAMFIELD WATER SYSTEM SPECIFIED
AREA

WHEREAS the Board of the Regional District of Alberni-Clayoquot (hereinafter referred as the "Regional District") pursuant to Section 482 of the Municipal Act may be empowered to impose and levy a parcel tax to meet the cost of works and services that benefit land or real property within the Bamfield Water System Specified Area (hereinafter referred to as "The Specified Area");

AND WHEREAS certain costs will be incurred by the Regional District in providing water services to lands within the Specified Area;

AND WHEREAS it is deemed desirable and expedient to impose and levy a parcel tax on land benefiting from such services to meet such costs;

NOW THEREFORE the Board of the Regional District of Alberni-Clayoquot in open meeting assembled, enacts as follows:


1. A tax (hereinafter referred to as "the parcel tax") shall be and is hereby imposed upon the owner of land or real property within the Specified Area which is capable of being connected to any water main, whether or not the parcel of land is connected to such water main.
2. The Parcel Tax shall be levied in each year on each of the aforesaid parcels of land and the amount thereof shall be \$145.00 on each parcel.
3. This By-law may be cited as the "Bamfield Water System Specified Area Parcel Tax By-law No. 329, 1981.
