**BYLAW NO. F1082**

**A BYLAW OF THE REGIONAL DISTRICT OF  
ALBERNI-CLAYOQUOT TO ESTABLISH RATES  
FOR THE MILLSTREAM WATER LOCAL SERVICE AREA**

WHEREAS the Board of the Regional District of Alberni-Clayoquot, constructed, operates and maintains a water system in the Millstream Water Local Service Area established by Bylaw No. 762 of the Regional District, (hereinafter called the Local Service Area’).

AND WHEREAS it is deemed necessary and expedient that provisions be made for a tariff of charges for water services;

NOW THEREFORE the Board of the Regional District of Alberni-Clayoquot in open meeting assembled enacts as follows:

**1. BILLING AND PAYMENT**

- (a) The several rates and charges enumerated in Schedule “A” of this Bylaw are hereby imposed and levied for water services supplied by the Regional District, Millstream Water System and all rates and charges shall be billed quarterly, one month in advance and shall be due and payable on or before the first (1<sup>st</sup>) day of the month following the issue of the bills.
- (b) When any rates or charges for water services are overdue for a period of six (6) months, such water services may be turned off from the premises and shall not be turned on again until payment has been received for the following:
  - 1. The rates and charges overdue;
  - 2. The rate as set out in Schedule “A” to cover the cost of turning the water on;
  - 3. Any additional cost incurred in order to prevent the improper use of water after the source has been turned off.
- (c) The Millstream Water Committee may assess an interest rate of 10% payable on all outstanding rates and charges which are overdue after a period of one (1) month.
- (d) The rates and charges specified in Schedule “A” and any assessed interest charges on the outstanding balance are due and payable by December 31<sup>st</sup> and if unpaid on that date shall be deemed to be taxes in arrears and shall be so entered on the tax roll by the Collector.

**2. RESCINDED**

Bylaw No. 928 cited as "Millstream Water Local Service Area Rates Bylaw 928, 1995" is hereby rescinded.

**3. TITLE**

This Bylaw may be cited as the "Millstream Water Local Service Area Rates Bylaw, 2009".


This Bylaw shall be into force and take effect on and after the date of final passing hereof.
