**BYLAW NO. F1166**

**A BYLAW OF THE REGIONAL DISTRICT OF  
ALBERNI-CLAYOQUOT TO IMPOSE FEES AND CHARGES FOR WEST COAST TRANSIT**

---

**WHEREAS** the Regional District of Alberni-Clayoquot has established a service for the purpose of providing public transit through *Bylaw No. E1062, West Coast Transit Services Area Establishment, 2019*;

**AND WHEREAS** in accordance with Bylaw No. E1062, the Board may recover the annual cost of providing the service, by the imposition of fees and charges in accordance with the *Local Government Act*;

**NOW THEREFORE** the Board of the Regional District of Alberni-Clayoquot in open meeting assembled enacts as follows:

**1. Citation**

This Bylaw may be cited as “*Bylaw No. F1166, West Coast Transit Fees and Charges Bylaw, 2024*”.

**2. Definitions**

In this bylaw the following definitions apply:

“10 Pass Booklet” means a booklet of ten (10) single ride passes purchased for the use of the transit system.

“Child” means an individual who is twelve (12) years of age or under.

“Day Pass” means a pass purchased for the use of the transit system and valid for a single calendar day.

“Monthly Pass” means a pass purchased for the use of the transit system and valid for thirty-one (31) days from the time of purchase.

“Single Ride Pass” means a pass purchased for the use of the transit system and valid for one (1) single ride.

“Student” means an individual who is thirteen (13) years of age or older and is enrolled in an educational program up to and including grade twelve (12).

**3. Fees and Charges**

Schedule A, attached hereto and forming part of this bylaw, is hereby adopted as the Fees and Charges for the Transit Service.

The fees and charges set out in Schedule A are hereby imposed on persons using the Transit Service and shall be paid in accordance with Schedule A.

**4. Effective Date**

This Bylaw comes into effect on April 10, 2024.
