- d. Air Quality Council, Port Alberni –M. Sparrow. Discussed home air filters, quite inexpensive (MERV-13 filters can remove more than 85% of PM2). Open burning is still an issue in the Alberni Valley, there are at least three avenues for improvement including: Promoting the Open Burning Smoke Control Regulation, promoting alternatives such as wood chipping (FireSmart Program), improve venting index information, education and compliance through radio public service announcements. AQC planning web and social media posts etc. Other avenues include collaborating with the Port Alberni Fire Department and using public message boards. The Alberni Valley has at least two local citizen groups interested in climate change including the Alberni Climate Action and Alberni Valley Transition Town Society.
