By-law P1194 - Rezoning Lot 4, District Lot 97, Alberni District, Plan 20663 from "Acreage Residential (RA2) to Acreage Residential (RA1) District" to allow for a two lot subdivision.  
(Robert and Irene East - 6785 Cherry Creek Road)




