A Public Hearing for residents and property owners within Electoral Area "F" will be held in the Alberni-Clayoquot Regional District Office, 3008 Fifth Avenue, Port Alberni, B.C. at 7:00 p.m. on May 12, 2008 to consider the following :

By-law P1212 to amend the Cherry Creek Official Community Plan By-law 626 by redesignating Lot A, District Lot 111, Alberni District, Plan 9149 and Lot 3, District Lot 111, Alberni District, Plan 1731, except Plan 9149 from "Rural Residential" to "Acreage Residential" to subdivide two existing lots that are 0.37 acres and 4.8 acres in area, and create two lots approximately 2.5 acres each.

By-law P1213 to rezone Lot A, District Lot 111, Alberni District, Plan 9149 and Lot 3, District Lot 111, Alberni District, Plan 1731, except Plan 9149 from Rural (A2) District to Small Holdings (A1) District to subdivide two existing lots that are 0.37 acres and 4.8 acres in area, and create two lots approximately 2.5 acres each

All persons who consider their interest in property affected by the proposed by-laws will be given an opportunity to be heard in matters contained in the by-laws.


