The Ministry of Forests, Lands, Natural Resource Operations and Rural Development (FLNRORD) supports the rezoning and development subject to the following conditions.

- As suggested, a covenant as road dedication be surveyed and registered on title with Land Title and Survey Authority (LTSA) to provide access to the Crown lands beyond. This has been identified as an extension of Taylor Arm Drive in Proposed Bare Land Strata Plan of Lot 45, District Lot 622, Clayoquot District, Plan 12452. If the Ministry of Transportation and Infrastructure (MOTI) requires this access road be dedicated as a highway or other legislated designation then MOTI's recommendations / conditions prevail.

- The Sproat Lake Official Community Plan will regulate activities within the riparian areas; however, should work occur within a stream the Water Sustainability Act still applies. If works are required in and about a stream as identified in the Water Sustainability Act, appropriate notification / authorization must be obtained prior to the commencement of such works.

- All other applicable legislation applies.
